1. INTRODUCTION

- 1.1 Article IX of the SADIS Agreement identifies that the United Kingdom shall furnish on or before 30 June of each year, a statement of the actual costs of the SADIS, expressed in pounds sterling, for the previous calendar year. These costs are identified in TABLE 1.
- 1.2 The format of the table is similar to that provided for previous years and is consistent with information provided in the SADIS Inventory. All table entries that related to the retired SADIS 2G system have now been removed, and a new section entered to cater for the upcoming development of a SADIS Test server in which costs will occur from 2019...

2. DISCUSSION

2.1 Notes relate to the actual costs for 2017 and forecast costs for 2018

a. Met Office to NATS Link

Communications costs between the SADIS Gateway, operated by NATS, and the Met Office are provided here. NATS own the links and are billed for the circuits., then NATS invoice the Met Office for the Met Office share of the costs.

b. Message Switch

These charges relate to the routing of data through into SADIS FTP.

c. Internet Bandwidth

Up until 27 April 2017 the bandwidth was 24Mbit/sec bursting 42Mbit/sec and was charged at an annual rate of £10,250. After this it was increased to 42Mbit/sec bursting 60Mbit/sec at an annual rate of £17,900. In November 2018 or December 2018 the bandwidth will be further increased to 80Mbit/sec bursting 120Mbit/s and the annual charge will drop to £8021 (agreed at METP-WG/MOG6)

d. Service Desk equipment

These charges cover equipment costs for the service desk functions

e. Ad-hoc maintenance

SCRAG/6 proposed that a charge of £5,000 be budgeted for ad-hoc maintenance activity in future years. There were only £32 of maintenance charges in 2017.

f. Help Desk and Other staff costs

The cost rates have been updated using the latest available figures. The percentage attribution rates can be found in the SADIS Inventory.

g. SADIS Test server and IWXXM data feeds

METP-WG/MOG6 Action 6/10 permitted the set up of a SADIS Test server facility. Costs to carry out this development work are expected to accrue in 2019.

h. Additional support

Administrative and professional support provided by the specified staff functions to the SADIS service.

i. Travel Costs

Actual travel and subsistence costs for Met Office staff to attend appropriate Meteorological Panel Working Groups (Meteorological Operations Group, WG-MOG, in relation to SADIS) and SCRAG meetings are included here.

j. Cost of Capital

Cost of capital for 2017 has been calculated using the revised methodology applied in 2008 and described in SCRAG/10 WP/13.

k. Administrative costs (bank charges, couriered invoices etc)

Following SCRAG Conclusion 14/7, this item includes costs relating to the processing of invoices (usually when administration charges reduce the amount actually received by the SADIS Provider by a small amount), or the cost of couriered invoices where normal surface mail is unreliable.

2.2 Notes on SADIS Gateway Costs

1. Staff Costs – Systems Engineers

SADIS Gateway costs were detailed in SCRAG10 WP/14 and the revised basis of calculation was applied from January 1st 2009.
