1. Introduction

1.1 This paper presents the estimated costs of providing the SADIS services in 2004 and the assessments of the States participating in the SADIS Cost Allocation and Recovery (SCAR) Arrangement for the year 2004.

2. Estimated SADIS Costs for the Period 1 January to 31 December 2004

2.1 **Table 1** below presents a summary of the estimated SADIS costs for the period 1 January to 31 December 2004. Details of these estimated costs are included in SCRAG/4-WP/9.

3. Cost Shares for the Period 1 January to 31 December 2004

3.1 In accordance with Article XI, paragraph 4 of the SADIS Agreement, any under-recovery of costs for the year 2002 arising from the failure of a Party to pay the SADIS cost share attributable to it for that year shall be added to the total SADIS costs to be shared for the year 2004.

3.2 As mentioned in the SCRAG/4-WP/7, one State, Namibia, which was assessed for the year 2002 by the SCRAG/2 Meeting, denied its accession to the SADIS Agreement. Therefore, this State was not considered in the final calculation of the shares of the actual costs for 2002 and of the calculation of the assessment of cost shares for 2004.

3.3 5 States, Indonesia, Morocco, Nigeria, the Russian Federation, and Turkmenistan, which were assessed for the year 2002 by the SCRAG/2 Meeting have not paid their SADIS cost shares for this year. The SADIS service to those States has been withdrawn, however, they are still included in the calculation of the assessment of cost shares for 2004 since communications with these States are still ongoing.

3.4 One State, Pakistan, which had initially denied its accession to the SADIS Agreement, sent a formal notification of accession in 2003. The SADIS service to this State was reinstated on 9 April 2003. This State is included in the calculation of the assessment of cost shares for 2004.

3.5 One State, Malaysia, paid its assessment for 2001 amounting to £18 941.81 after the SCRAG/3 Meeting in November 2002. Therefore, this payment will be considered as a collection for 2002 in **Table 2** below.

3.6 Table 2 below presents a summary of the calculation of the amount to be assessed under the SADIS Agreement for 2004.

3.7 Taking into account the information in Tables 1 and 2 and paragraphs 3.2 to 3.5 above, the **Attachment** shows, for the period 1 January to 31 December 2004, the estimated cost share to be borne by each State receiving the SADIS service, based on their 2002 available tonne-kilometres in scheduled services (ATKs), as well as their share of the over-recovery for 2002, in accordance with Article XI, paragraph 4 of the SADIS Agreement.

4. Action by the Group

4.1 The Group is invited to:

- a) review the estimated costs of providing the SADIS services for the period 1 January to 31 December 2004 totaling £565 184, presented in Table 1 above;
- b) note the information presented in paragraphs 3.2 to 3.5 above; and
- c) determine the assessments for the period 1 January to 31 December 2004 of the States participating in the SCAR scheme in 2004 on the basis of their number of ATKs for 2002, as presented in the Attachment.
