1. Introduction

1.1 This paper presents the estimated costs of providing the SADIS services in 2009 and the assessments of the States participating in the SADIS Cost Allocation and Recovery (SCAR) Arrangement for the year 2009.

2. Estimated SADIS Costs for the Period 1 January to 31 December 2009

2.1 **Table 1** below presents a summary of the estimated SADIS costs for the period 1 January to 31 December 2009. Details of these estimated costs are included in SCRAG/9-WP/10.

3. Cost Shares for the Period 1 January to 31 December 2009

- 3.1 In accordance with Article XI, paragraph 4 of the SADIS Agreement, any under-recovery of costs for the year 2007 arising from the failure of a Party to pay the SADIS cost share attributable to it for that year shall be added to the total SADIS costs to be shared for the year 2009.
- 3.2 One State, Morocco, which had the service withdrawn on 6 August 2002, was included in the calculation of the assessment of cost shares for 2008 since it was considering asking that the service be reinstated. Considering that no official request to reinstate the service was received to date, Morocco is not included in the calculation of the assessment of cost shares for 2009.
- 3.3 One State, Malaysia, decided to terminate its participation in the SADIS programme in view of cost constraints and the need to rationalize their operations. Consequently, Malaysia is not included in the calculation of the assessment of cost shares for 2009 and its share of the actual costs for 2008 will be calculated based on five full months of service in 2008.
- 3.4 Four States, Algeria, Lebanon, Republic of Korea and Syrian Arab Republic, will have the service withdrawn at the end of October 2008. Consequently, these four States are not included in the calculation of the assessment of cost shares for 2009.
- 3.5 The service to Kenya and Nigeria was reinstated respectively on 12 August 2008 and on 30 January 2008. Consequently, these two States are included in the calculation of the assessment of cost shares for 2009.
- 3.6 Three new receiver States, Latvia, Libyan Arab Jamahiriya and Lithuania, are included in the calculation of the assessment of cost shares for 2009 considering that they receive the SADIS service respectively since 1 March 2007, 1 January 2007 and 1 January 2007.
- 3.7 **Table 2** below presents a summary of the calculation of the amount to be assessed under the SADIS Agreement for 2009.

3.8 Taking into account the information in Tables 1 and 2 and paragraphs 3.2 to 3.6 above, the **Attachment A** shows, for the period 1 January to 31 December 2009, the estimated cost share to be borne by each State receiving the SADIS service, based on their 2007 available tonne-kilometres in scheduled services (ATKs), as well as their share of the under-recovery for 2007, in accordance with Article XI, paragraph 4 of the SADIS Agreement. **Attachment B** shows the amounts to be billed to each State in 2009, corresponding to the adjustment for 2007 (Attachment to SCRAG/9-WP/7) plus the assessment for 2009 (Attachment A).

4. **Action by the Group**

4.1 The Group is invited to:

- a) review the estimated costs of providing the SADIS services for the period 1 January to 31 December 2009 totaling £892 915, presented in Table 1 above;
- b) note the information presented in paragraphs 3.2 to 3.6 above; and
- c) determine the assessments for the period 1 January to 31 December 2009 of the States participating in the SCAR scheme in 2009 on the basis of their number of ATKs for 2007, as presented in the Attachment.
