1 INTRODUCTION

1.1 The United States (U.S.) continues to believe that existing International Civil Aviation Organization (ICAO) Standards and Recommended Procedures (SARPs) when utilized properly, afford States the ability to coordinate the necessary notifications for space operations to be conducted in a safe and efficient manner.

2. DISCUSSION

2.1. In APIRG/26 WP031B, paragraph 3.1 (e) the U.S. invited the meeting to “recommend that States conducting or supporting space launches consider coordinating using direct email and AMHS in addition to diplomatic notifications.” The U.S. would like to clarify that the specific diplomatic notification referred to in this recommendation is the pre-launch notification outlined in the International Code of Conduct Against Ballistic Missile Proliferation, commonly known as the Hague Code of Conduct (HCOC).

2.2 States which are signatories to the HCOC have voluntarily committed themselves to providing pre-launch notifications on space vehicle launches. These notifications are not intended to be used for operational or airspace integration purposes and rather serve as a mechanism for States’ awareness.
