The Purpose of this presentation is to give an overview of the On-Aeroplane Upset Prevention and Recovery Training that we at Ultimate High provide.





The ICAO UPRT Manual (document 10011) mandates three types of Upset Prevention and Recovery Training





Academic

FSTD or Simulator

On-Aeroplane





Academic UPRT

Required by CARs for CPL(A) or MPL training and also a part of recurrent line training







FSTD or Simulator UPRT

Required by CARs for recurrent line training where a suitable, qualified simulator is available.

* 'suitable, qualified' because of the danger of negative training.







On-Aeroplane UPRT

Required by CARs for CPL(A) or MPL training and also a part of recurrent line training where no suitable or qualified simulator is available.







On-Aeroplane UPRT

Carried out in suitable light aeroplanes by qualified instructors to develop the knowledge, awareness and experience of aeroplane upsets and unusual attitudes, and how to effectively analyse the event and then apply correct recovery techniques.







ADVISORY CIRCULAR CAA-AC-OPS005 August 2024

LOSS OF CONTROL IN FLIGHT (LOC-I) AND UPSET PREVENTION AND RECOVERY TRAINING (UPRT)

1.0 PURPOSE

This Advisory Circular (AC) provides guidance to Air Operator's Certificate (ACC) holders, Approved Training Organization (ATO) providers conducting operations, and other organizations using type-rated aircraft for training with checking capability for the implementation, operation, and approval of Upset Prevention and Recovery Training (UPRT) programs to ensure pilots are trained in the correct recovery responses and to integrate UPRT considerations into Crew Resource Management (CRM) training programs.

ICAO's UPRT Manual (and the IATA UPRT Manual) contain mitigation strategies to achieve acceptable levels of safety.

Ultimate High developed its UPRT on-aeroplane syllabus by following UK CAA Technical Guidance Material - which itself is a copy of EASA's Acceptable Means of Compliance and Guidance Material. This material follows ICAO SARPs in the ICAO Manual and in ICAO Annexes.

In East and Central Africa CASSOA has followed suit with its own UPRT Advisory Circular that has been developed from the same source material.





CASSOA's Model Advisory Circular on LOC-i and UPRT sets out the On-Aeroplane requirements for:

- Instructor qualification and experience,
- Suitability of aircraft,
- Operations base,
- Safety culture and,
- UPRT programme syllabus.
