SUMMARY

This paper presents an excerpt of the *Asia and Pacific Region ATS Route Catalogue* Version 12 for review and consideration.

1. INTRODUCTION

- 1.1 Version 12 of the *Asia/Pacific ATS Route Catalogue* as endorsed by the Twenty-fourth Meeting of the Asia/Pacific Air Navigation Planning and Implementation Regional Group (APANPIRG) is available at the ICAO Asia/Pacific website (http://www.bangkok.icao.int/) under the menu 'APAC eDocuments'. The Catalogue records the current status of the international route requirements in the *Basic Air Navigation Plan* (BANP, Volume I of Doc 9673) and does not require any formal approval to be included in the Catalogue.
- 1.2 The Route Catalogue provides two functions it contains updated information from the Regional Air Navigation Plan (Doc 9673), until such time as this is in electronic form, and it contains a number of proposals for route changes that have not been agreed by States yet. The structure of the Catalogue is as follows:
 - Chapter A: The unofficial but electronic, up-to-date version of the BANP;
 - Chapter 1: Route Requirements Users and States (South Asia);
 - Chapter 2: Route Requirements Users and States (Southeast Asia);
 - Chapter 3: Route Requirements Users and States (East Asia/Russian Federation); and
 - Chapter 4: Route Requirements Users and States (Pacific).
