Sir/Madam,

I refer to State Letter Ref. T3/10.1.1-AP145/13 (ATM) dated 08 October 2013, regarding the Second Meeting of the ICAO Asia/Pacific Search and Rescue Task Force (APSAR/TF/2), which was scheduled to be held at the ICAO Asia and Pacific Regional Office in Bangkok from 27 – 31 January 2014.

Due to the political unrest being experienced in Thailand at present, there is uncertainty as to the effect on the Regional Office's facilities and the availability of safe and efficient land transportation within Bangkok over the coming weeks. The ICAO Regional Office has gratefully accepted Singapore's kind offer, thus allowing a meeting of three and a half days (scheduled to be complete by lunchtime on Thursday 30 January 2014).

Accordingly, I wish to invite your Administration to arrange for attendance at the new location of suitable SAR experts at this important meeting. I am requesting that you kindly provide, at your earliest convenience, the name(s) of the delegate(s) from your State that will be attending the meeting.

An updated Meeting Bulletin for Singapore will be circulated electronically by e-mail and available on the Regional Office web site in due course. The meeting is due to be held at the Singapore Aviation Academy, close to Changi International Airport. An updated Meeting Bulletin is attached at Attachment A.

Please be advised that the Regional Office will not be able to accept late papers for this meeting after Wednesday 22 January 2014.
