#### Background

• Article 14 of the Chicago Convention requires that Member States take measures to prevent the spread of communicable disease

 Assembly Resolution A35-12 states "the protection of the health of passengers and crews on international flights is an integral element of safe air travel".





#### Background

 Assembly Resolution A37-13 urges Member States to join and participate in the Cooperative Arrangement for the Prevention of Spread of Communicable Disease through Air Travel (CAPSCA) programme.



#### **Increased Scope...Public Health Events**

IG 70 YEARS OF

**IICAGO CONVENTION** 

 The title of the programme was changed in 2013 to the Collaborative Arrangement for the Prevention and Management of Public Health Events in Civil Aviation, while retaining the same acronym, to reflect the increased scope of the programme beyond that of communicable disease, for example, radionuclear accidents.





#### **Relevance of CAPSCA**

 A number of health-related amendments were made to provisions in ICAO Annexes, Procedures and Technical Instructions.

 Since May 2013, protocol questions in the Universal Safety Oversight Organization Programme have addressed these issues





#### **Future Funding of CAPSCA**

- The 2013 Assembly reiterated its support for CAPSCA and "encouraged States and international organizations to contribute to CAPSCA financially and/or in kind".
- Ref.: AN 5/28-14/33 ; 11 April 2014
- Appeal to the States, Organizations and Industry to contribute to ICAO's voluntary Safety Fund (SAFE) earmarked for CAPSCA
