Sir/Madam,

I have the honor to invite your Administration to participate in a COM Co-ordination Meeting to be held in Chengdu, China from 18 to 19 February 2014. The meeting will be hosted by the Air Traffic Management Bureau (ATMB) of Civil Aviation Administration of China.

The objective of the meeting is to review the circuit performance and operational status of Aeronautical Fixed Service (AFS) including ATS direct speech and AFTN communication circuits between States. The meeting will also review the follow-up actions taken by the Administrations on the Action Plan agreed at the previous meeting held in March 2013. The COM Co-ordination Meeting is also expected to develop more practical and solid implementation plan for improving AFS communications in the Sub-region. The meeting will also initially develop a roadmap for AIDC implementation between capable ATM systems of neighbouring States.

The Provisional Agenda and Nomination Form are attached in Attachments A and B respectively. The Meeting Bulletin will be forwarded to you separately at a later date.
