REVIEW OF AFS REQUIREMENTS

SUMMARY

This paper presents relevant requirements for AFS circuits as outlined in the regional air navigation plan document for review by this meeting.

1. Introduction

1.1 The requirements for the AFS and communications are specified in the ASIA/PAC Basic Air Navigation Plan (ANP) and the ASIA/PAC Facilities and Services Implementation Document (FASID).

2. Discussion

- 2.1 Based on the development trend of regional air navigation planning process, the regional air navigation planning document would become part of e-ANP which has been recommended by AN Conf/12 held in November 2012 in Montreal. The structure change of planning document and access method is being developed by a global Task Force.
- 2.2 In accordance with the regional planning documents, following circuits are considered relevant for review by the meeting:

Aeronautical Fixed Service Data Communication (AFTN/AMHS) Circuits

- 1) Beijing (ZBBB) / Yangon (VYYY) (Suspended);
- 2) Beijing (ZBBB)/Kathmandu (VNKT) (Need to be upgraded as the existing VSAT degrading);
- 3) Yangon (VYYY)/Bangkok/VTBB circuit (status needs to be reviewed);
- 4) Bangkok (VTBB)/Vientiane (VLVT) (status to be reviewed);

- 5) Kathmandu(VNKT)/Mumbai (VABB) (status to be reviewed); and
- 6) Phnom Penh (VDPP)/Bangkok (VTBB) (status to be reviewed).
