Sir/Madam,

I have the honor to invite your Administration to the Third Meeting of the Common Regional Virtual Private Network Task Force (VPN) of Asia/Pacific Air Navigation Planning and Implementation Regional Group (APANPIRG CRV TF/3) to be held at the ICAO Regional Office, Bangkok, from 9 to 12 December 2014. The meeting will be supported by the Aeronautical Radio of Thailand Ltd. (AEROTHAI).

The objective of the meeting is to progress the study of the future aeronautical network CRV for the APAC region as tasked by the APANPIRG.

You may wish to recall that APANPIRG made a Decision 24/32 to establish a Task Force consisting of the Subject Matter Experts (SME) to study regional virtual private network (VPN) and develop a detailed proposal by January 2016.

The meeting will consist of 2 sessions:

- Session 1 with Communication Service Providers (having received confirmation from ICAO APAC Office), which will last approximatively one to two days; and
- Session 2 without Communication Service Providers - CRV project progress

For the session 1, the concerned Communication Service Providers will be invited in November 2014 following their submission according to the (Request for Information) RFI process.

The provisional agenda of the meeting is provided in Attachment 1. A meeting bulletin containing information about the meeting arrangements is provided in Attachment 2.
