1. Meeting and Registration

- 1.1 The Third Meeting of the Safety Reporting and Programme Ad hoc Working Group (SRP AWG/3) was held at the ICAO Asia Pacific Office in Bangkok, Thailand on 15 September 2014.
- 1.2 The SRP AWG/3 Meeting was attended by 31 participants from 11 States/Administrations and 4 International Organizations and Industry Partners viz. Australia; Bangladesh; Brunei Darussalam; Hong Kong, China; France (New Caledonia); Japan, Nepal, Philippines, Republic of Korea; Singapore; United States; IATA; IFALPA; Airbus; Boeing; and ICAO. 2. Opening Session and Meeting Arrangements

2.1 SRP AWG Vice-Chair (States), Mr. Ben Gyetvay, welcomed the participants on behalf of the President of the ICAO Council, Secretary General of ICAO and the Bangkok Office.

3. REPORT ON AGENDA ITEMS

AGENDA ITEM 1: ADOPTION OF AGENDA

- 1.1 The SRP AWG Vice-Chair (States) noted the main activities of the Meeting were:
 - Update on activity of the SRP AWG for other tasks;
 - IAT to provide update on progress of analysis for the 2014 APAC Annual Safety Report; and
 - Update on timeframes for the completion of the 2014 APAC Annual Safety Report.

AGENDA ITEM 2: UPDATE ON ACTIVITY OF THE SRP AWG

- 2.1 The SRP AWG was concentrating on the production of the 2014 Annual Safety Report. Regarding Conclusion 3/3 from APRAST/4 regarding the SRP AWG undertaking the initiative on the sharing of information on potential precursors to air accidents, it was noted that the Regional Data Collection, Analysis, and Sharing System (RDCAS) would be an effective way of gathering this information. Further, RDCAS could play a crucial role in measuring effectiveness of Safety Enhancement Initiatives (SEIs) and identifying emerging issues.
- 2.2 The Information Analysis Team (IAT) supports the establishment of a Regional Data Collection, Analysis, and Sharing System (RDCAS). As part of the development of the RDCAS the IAT recommends that it collects information on TAWS, TCAS RA, Unstable Approaches, and stall warnings in order to measure vulnerabilities and the effectiveness of current Safety Enhancement Initiatives (SEIs) already approved by RASG.

AGENDA ITEM 3: IAT TO PROVIDE UPDATE OF PROGRESS ON THE 2014 APAC ANNUAL SAFETY REPORT

- 3.1 The IAT has been waiting on the receipt of information from various stakeholders which has delayed the analysis phase of the report. Work had commenced on various sections of the report however a draft version was unable to be shown to the meeting at this time.
- 3.2 Singapore provided an update on the progress of the reactive section of the Report, and noted that they had commenced this section of the report using ICAO iSTARS information. IATA, CAST, and Boeing stated they would work with the IAT to provide the information as soon as possible.
- 3.3 CAST provided the meeting with an overview of the dashboard created for APAC within ASIAS. It was noted that although excellent information, it was unlikely that any findings could be made due as the information was only a small subset of activity in the region and was not representative. Nonetheless, it provided an excellent overview of what could be achieved should the RDCAS initiative proceed.
- 3.4 Following a question from Bangladesh, Singapore provided an explanation and presentation of the production of the Annual Safety Report, including where information was sourced from and how it was used.
- 3.5 The ICAO APAC Secretariat showed the Meeting where the 2013 Annual Safety Report was located on the secure portal.
- 3.6 The Vice-Chair (States) provided a brief overview of the information presented in the 2013 Annual Safety Report to show the comparisons and use of information as discussed earlier by Singapore.
- 3.7 The APRAST Vice-Chair (Industry) updated the Meeting of the recent coordination meeting between RASG-APAC and APANPIRG which would lead to enhance information sharing and coordination of aviation safety matters. A Working Paper will be presented at APRAST/5 on the outcomes of the meeting.

AGENDA ITEM 4: UPDATE OF TIMEFRAMES FOR THE COMPLETION OF THE 2014 APAC ANNUAL SAFETY REPORT

- 4.1 The following dates were provided as targets by the IAT for completion of the 2014 APAC Annual Safety Report
 - Draft Report will be completed by 17 October 2014.
 - Report circulated to SRP AWG Members for comment, comments to be received by 24 October 2014.
 - Feedback incorporated by 31 October 2014.
 - Draft provided to APRAST Co-Chairs on 3 November 2014 for their consideration and submitting to RASG-APAC.
 - The target date for completion of the Report is 15 December 2014.

AGENDA ITEM 5: ANY OTHER BUSINESS

- Bangladesh noted that they and many other countries required assistance to ensure reporting was maximized to assist safety outcomes. Although predictive information was the road ahead, it was important to also maximize reporting for reactive information and that basic requirements were understood.
- 5.2 It was discussed that as the APAC Annual Safety Report was published at the regional level, there would be value in using the SRP AWG/4 to examine information and discuss the analysis of the 2014 APAC Annual Safety Report at the state level. This information would not be included in the Annual Safety Report, but would provide an opportunity for participants to understand safety issues and their mitigations.
- 5.3 The following provisional agenda for SRP AWG/4 was proposed:
 - Discussion of information underlying the 2014 APAC Annual Safety Report (closed door meeting).
 - Discuss the timeframes for the production of the 2015 APAC Annual Safety Report.
 - Update on the activities of the IAT
