## STATUS OF CONCLUSIONS FROM APAC-AIG/2

## **SUMMARY**

This paper summarises the status of the conclusions from APAC-AIG/2.

## 1. INTRODUCTION

1.1 The Second Meeting of the Asia Pacific Accident Investigation Group (APAC-AIG/2) was held on 27 - 28 May 2014 in Hong Kong, China, during which 5 conclusions were developed. The APAC-AIG/2 conclusions are listed in **Attachment A**.

## 2. DISCUSSION

2.1 The following has been achieved since APAC-AIG/2:

2.2 An ICAO State Letter dated 28 January 2015 [Ref. T 10/5.4- AP 016/15 (FS)] was sent by the ICAO APAC Regional Office to draw the attention of States/Administration of the upcoming new standard, and encouraged States/Administrations that have not yet established an independent accident investigation authority to do so as soon as possible.

2.3 The State Letter also informed States/Administrations planning to set up an independent accident investigation authority may consult RASG-APAC's Asia Pacific Accident Investigation Group (APAC-AIG) if necessary.

## **3.** ACTION BY THE MEETING

3.1 The meeting is encouraged to establish an independent investigation system and consult RASG-APAC's Asia Pacific Accident Investigation Group (APAC-AIG) is necessary.
