# REPORT ON THE THIRD MEETING OF THE ASIA PACIFIC ACCIDENT INVESTIGATION GROUP

(Presented by the Chairman APAC-AIG)

#### **SUMMARY**

The Asia Pacific Accident Investigation Group held its Third Meeting on 23 - 24 June 2015. Issues discussed at the meeting included ICAO initiatives, independent investigation authority, investigator training and regional cooperation.

#### 1. Introduction

1.1 The APAC-AIG held its Third Meeting (APAC-AIG/3) in Colombo, Sri Lanka on 23–24 June 2015, in conjunction with Sri Lanka's hosting of an ICAO Asia Pacific Regional Accident Investigation Workshop on 25 – 26 June 2015. The APAC-AIG/3 Meeting was attended by 44 participants from 18 Member States/Administrations and four international organization/industry partners. One representative from Qatar also participated in the meeting at the invitation of the Chairman APAC-AIG.

#### 2. DISCUSSION

2.1 The key outcomes from APAC-AIG/3 are as follows:

#### • Database of investigation agencies

A database of the investigation agencies in the APAC region had been created to allow States/Administrations to obtain contact information of their counterparts easily and facilitate expeditious communication among States/Administrations. To date, 19 States/ Administrations have provided input to the database. They are Australia, Bangladesh, Cambodia, China, France, Hong Kong China, Japan, Macau China, Maldives, Mongolia, Myanmar, Nepal, New Zealand, Papua New Guinea, Philippines, Republic of Korea, Singapore, Sri Lanka and Thailand.

## • Code of Conduct on investigation cooperation

The Asia-Pacific Code of Conduct on Cooperation Relating to Civil Aviation Accident/Incident Investigation was developed to promote mutual cooperation in accident/incident investigation in the APAC region. To date, 18 States/Administrations have pledged their support to the Code of Conduct. They are

Australia, Bangladesh, China, France, Hong Kong China, Indonesia, Japan, Lao PDR, Macau China, Maldives, Mongolia, Myanmar, New Zealand, Philippines, Republic of Korea, Singapore, Sri Lanka and Thailand.

### • Establishing an independent accident investigation authority

The Meeting agreed that ICAO should provide more guidance as to how a State/Administration can demonstrate the independence of its accident investigation agency.

Papua New Guinea shared its experience and challenges in establishing its Accident Investigation Commission, which is an independent accident investigation agency. The meeting was apprised of the agency's reporting structure, staff strength, expansion plans. The meeting also noted Australia's assistance to Papua New Guinea in developing the agency's capabilities.

## • <u>Classification of occurrences</u>

The Meeting discussed and noted that the classification of an occurrence may not always be straightforward. The definitions of "accident" and "serious incident" may be difficult to interpret because of ambiguity.

States/Administrations are invited to inform ICAO APAC Office and Chairman APAC-AIG before 24 August 2015 if they have any suggestion to refine/enhance ICAO Annex 13's definitions of "accident" and "serious incident" to reduce ambiguity.

- 2.2 The APAC-AIG/3 meeting developed five conclusions (see **Attachment A**).
- 2.3 The Meeting updated the APAC-AIG work plan, as tabulated in **Attachment B**. The work plan identifies upcoming investigation-related event and activities and should facilitate States/Administrations' in planning for their participation. States/Administrations are also encouraged to consider volunteering to organise the events and activities.
- 2.4 The Fourth Meeting of the APAC-AIG (APAC-AIG/4) will be hosted by Japan in 2016 in conjunction with its hosting of an accident investigation workshop of the Asian Society of Air Safety Investigators (AsiaSASI). The date of the APAC-AIG/4 will be advised later.

## 3. ACTION BY THE MEETING

- 3.1 The Meeting is invited to:
  - a) Note the APAC-AIG work plan;
  - b) Note the invitation to States/Administrations to suggest improvement to the definitions of "accident" and "serious incident"; and
  - c) Note that Japan will be hosting the APAC-AIG/4 and an AsiaSASI accident investigation workshop in 2016.
