SUMMARY

This paper introduces the evaluation plan and evaluation form that will be used to compare the proposals.

1. Introduction

- 1.1 A tender package has been developed by the CRV Task Force to procure network services.
- 1.2 This paper introduces the evaluation package that has to be reviewed in view of its use by the CRV evaluation committee.

2. Discussion

- 2.1 The evaluation form delivered by **Task 37-c Make user Requirements** was commented by APAC States in June 2015 and consolidated by **Task 38 Determine Selection Process** composed of CRV Chair, ICAO RO CNS Officer and ICAO TCB expert from 29 June to 10 July 2015.
- 2.2 The evaluation package consists of:
 - Evaluation of CRV Services form
 - Guidance for CRV evaluation committee member
- 2.3 The form Evaluation of CRV Services is based on ICAO procurement code and practices and uses the ICAO template.
- 2.4 The guidance for CRV evaluation committee member refines the criteria developed in the aforementioned form to constitute a sound and fair basis for evaluation, as potentially all Pioneer States may want to contribute to the evaluation process.

- 2.6 Concerning the process (evaluation plan) it is proposed to:
 - Limit the participation to 1 member by State/Administration
 - Groups be constituted as follows, based on the successful experience with RFI
 - o GROUP 1:
 - TECHNICAL CRITERIA 1 Corporate Experience and Capability
 - TECHNICAL CRITERIA 2 Proposed Work Plan and Approach
 - o GROUP 2:
 - TECHNICAL CRITERIA 3 Skill and Experience of Personnel
 - TECHNICAL CRITERIA 4 Additional Criteria (Network design and user's interface, Configuration management, Fault management, Security management, Monitoring and reporting, Training, optional gateway service)
 - o **GROUP 3:** Financial criteria
 - 1 member can contribute to 1 to 3 groups
 - Technical criteria: this member prepares his/her pre-evaluation form before the evaluation meeting (for groups 1 and 2)
 - Based on the inputs from members, a score is given to all criteria in accordance with the guidance. If based on discussions a score cannot be given for a specific criterion, then the average of all notes for that criterion will be retained.
 - for the financial criteria no pre-evaluation has to be carried out as the Case study will be directly used to evaluate the financial criteria for each tender.
- 2.7 The evaluation form will be reviewed by ICAO in accordance with the ICAO procurement code.
