- Doc 9303: Machine Readable Travel Documents (TAG/MRTD)
- Doc 9303 standard formats:
 - \rightarrow clearance of persons
 - \rightarrow document security
 - \rightarrow strengthen aviation security
 - \rightarrow combat illegal migration & terrorism, etc.
- ICAO-compliant TDs secure: latest generation difficult to forge
- BUT: vulnerability in identification management

- vulnerability in identification management
- Insecure documents used for passport application/issuance

IDENTITY FRAUD

- False identities \rightarrow Genuine documents
- TAG/MRTD work: expanded to include identification management
- Expansion of the work of the MRTD Programme
- Approval of a new ICAO TRIP Strategy by A38





• <u>Vision</u>:

all Member States can uniquely identify individuals

• ICAO's mission:

contribute to the capacity of Member States to uniquely identify individuals by providing authorities with relevant supporting mechanisms to establish and confirm the identity of travellers





5 Elements of Traveller Identification Management

1. Evidence of identity:

 \rightarrow involves tracing, linkage & verification of identity against breeder documents

 \rightarrow to ensure genuineness of identity

2. <u>MRTDs</u>:

 \rightarrow design and manufacture of standardized MRTDs that comply with ICAO specifications

3. Document issuance and control:

 \rightarrow processes for document issuance by appropriate authorities to authorized holders; controls to prevent theft, tampering, loss





5 Elements of traveller identification management

4. Inspection systems and tools:

 \rightarrow inspection systems for efficient and secure reading and verification of MRTDs

→ use of the ICAO Public Key Directory

5. Interoperable applications:

 \rightarrow globally interoperable applications linking MRTDs and holders to relevant data in the course of inspection operations

ICAO TRIP Relevance to UN CT Strategy Security Council Resolution 1373 (2001)

"The Security Council . . .

2. *Decides also* that all States shall:

(g) Prevent the movement of terrorists or terrorist groups by effective border controls and controls on issuance of identity papers and travel documents, and through measures for preventing counterfeiting, forgery or fraudulent use of identity papers and travel documents."



ICAO TRIP Relevance to UN CT Strategy Security Council Resolution 1624 (2005)

"The Security Council,

2. *Calls upon* all States to cooperate, inter alia, to strengthen the security of their international borders, including by combating fraudulent travel documents and, to the extent attainable, by enhancing terrorist screening and passenger security procedures with a view to preventing those guilty of committing terrorist acts from entering their territory"





ICAO TRIP Relevance to UN CT Strategy Security Council Resolution 2178 (2014)

"The Security Council,

2. *Reaffirms* that all States shall prevent the movement of terrorists or terrorist groups by effective border controls and **controls on issuance of identity papers and travel documents**, and through measures for **preventing counterfeiting, forgery or fraudulent use of identity papers and travel documents**...





Assistance to States: needs

Enormous challenges and gaps in developing and fragile countries:

- Weak capacity to uniquely identify individuals for the purposes of border controls, terrorism prevention and law enforcement
- Lack of robust identification management systems
- Identity and travel document fraud used for engaging in terrorism and organised trans-border crime





- Staff lacking **competences**, **skills** and tools
- Lack of trust and technical means required for effective inter-agency and cross-border cooperation
- Inadequate traveller identification management and border controls
- Considerable mobility of cross-border populations

Recent ICAO TRIP Assistance Activities, in Europe and Central Asia



Gap assessment missions, technical consultations and assistance with MRTD and eMRTD tenders in:

•Tajikistan, Uzbekistan, Georgia, Kyrgyzstan

A new project proposal for the TRIP Strategy implementation in Central Asia and Eastern Europe developed – donor funding is sought MRTD/TRIP Regional Seminars in:

- •Uzbekistan April 2014
- •Spain June 2014 (with interoperability tests for ePassports)

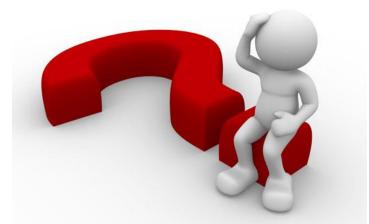
