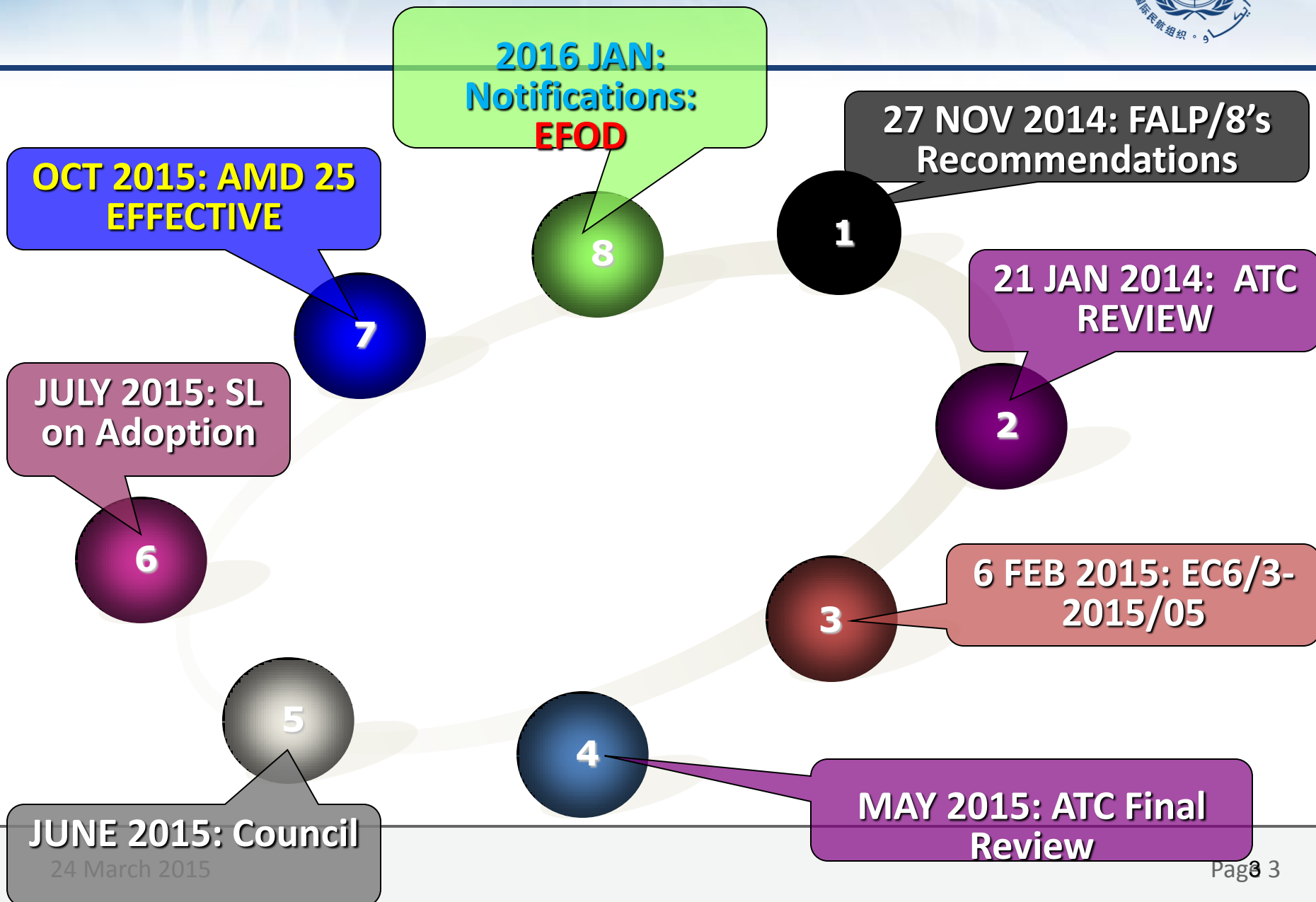

## 1. FALP/8: 24-27 NOVEMBER 2014

### Item 2: Proposals to amend Chapter 3

1. States should join the PKD (2 RPs)
  - Issuing or intending to issue eMRTDs
  - Checking eMRTDs at borders
2. INTERPOL's Stolen and Lost Travel Documents (SLTD) database
  - Standard: Information on stolen, lost, revoked TDs
  - RP: At departure, entry points: query database
3. **Standard:** "Convention TDs" are machine readable (Doc 9303) [refugees & stateless persons] [**UNHCR**]



## Item 2: Proposals to amend Chapter 4

1. Definitions for “Authorised Economic Operator (AEO)” and “Single Window”
2. RP: States: introduce programmes for AEOs
3. RP: Mutual recognition of AEOs by States
4. RP: Parties - air cargo operations: submit information (arrival, stay and departure of an aircraft and air cargo) to a **single entry point** (Single Window).

## Item 2: Proposal to amend Chapter 8

- Contracting States should establish legislation, regulations and/or policies in support of assistance to aircraft accident victims and their families.



## Items 3 & 4

- Working Group on Guidance Material (WGGM)
  - **Model National Air Transport Facilitation Programme**
- New WG: improve usage and implementation of passenger data systems
- Feasibility study by Secretariat: Audit of all Annex 9 Standards
- WGGM: guidance materials on self-service passenger processes





## STATE LETTER EC6/3-2015/05

- 6 February 2015
- Comments: deadline 31 March 2015
  - **Agreement without comments**
  - **Agreement with comments [e.g. reservations; alternate proposal]**
  - **Disagreement without comments**
  - **Disagreement with comments**
  - **No position**



## ATC FINAL REVIEW & CONSIDERATION BY COUNCIL

- May 2015: Final review of FALP/8 proposals
- June 2015: Proposals submitted to Council for consideration
- July 2015: (if adopted) SL on adoption
- 26 October 2015: Disapprovals; Effective date of Amd. 25
- 26 January 2016: Notifications: Compliance / Differences
- 26 February 2016: Applicable date of Amd. 25



## Action by States

1. Respond to EC 6/3-2015/05
2. Respond to SL: Adoption of Amendment 25
  - Notify disapprovals, if any
  - Notify compliance with Annex 9 (“up to and including Amd. 25”)
  - Notify differences with any provision of Annex 9
