SUMMARY

This paper presents the recent activity of the ADS-B implementation in Mongolia.


1. INTRODUCTION

1.1 This information paper provides recent activity of ADS-B implementation in Mongolia.

2. DISCUSSION

2.1 The Civil Aviation Authority of Mongolia (CAAM) confirmed the plan of implementing ADS-B technology in Air Navigation surveillance services in 2014. Currently CAAM installed 10 ADS-B stations with DO260 standards along the main en-routes.

- 2.2 All ADS-B stations are connected to ATS automation system /AIRCON 2100 INDRA/ in order to perform monitoring trail process. The Monitoring trail will be active until January 2016.
- 2.3 CAA Mongolia plans to use these ADS-B stations as back-up system for the SSR system, except the Western area of Mongolian airspace. Within the Western area, additional 5 ADS-B stations will be installed and will provide ADS-B service.
- 2.4 Providing ADS-B services, requires CAA Mongolia updating its ATS automation system in accordance to the standards of DO260B and DO260A. These updates will be initiated by 2016.

3 ADS-B implementation working group cooperation activity

- 3.1 ADS-B implementation working group invited MAAR agents to Mongolia for improving our collaboration. MAAR provided necessary information to CAA Mongolia and supported our application for ADS-B data processing.
- 3.2 The team also visited Airservices Australia for studying the progress of ADS-B implementation in Australia. The Airsevices provided helpful information for the Mongolian ADS-B implementation working group.
- 3.2 CAA Mongolia also requested to visit Republic of Indonesia for studying their documents and procedures regarding the ADS-B implementation.
- 3.3 Currently, the Regulator and ADS-B implementation working group of CAA Mongolia are planning to activate ADS-B mandate by 2018. CAA Mongolia is now studying how ADS-B can be used in operation, before it becomes mandatory. Respectively, CAA Mongolia is interested in learning from Indonesian ADS-B implementation method.
