**OUTCOME OF DGCA CONF/52 ON ADS-B**

**SUMMARY**

This paper presents the ADS-B related outcome of 52nd Conference of Directors General of Civil Aviation (DGCA), Asia and Pacific Regions held from 26 to 30 October 2015 in Manila, Philippines for consideration by the meeting.

**1. Introduction**

1.1 The 52<sup>nd</sup> Conference of Directors General of Civil Aviation (DGCA), Asia and Pacific Regions, hosted by the Philippines, was held in Manila from 26 to 30 October 2015. The Conference was attended by 294 delegates from 35 States/Administrations and International Organizations.

**2. Discussion**

2.1 Under agenda item 3.3 - Air Navigation matters, the meeting received a number of papers on ADS-B listed below:

- DP1 The outcome of APANPIRG/26 presented by ICAO;
- DP8 Cost and Benefits for the initial phase of ADS-B Implementation over the South China Sea by Singapore and CANSO;
- IP28 ADS-B project in French Polynesia by France;
- IP32 ADS-B Implementation Status in China;
- IP40 ADS-B in New Caledonia;
- IP51 Preparedness for ADS-B 2020 equipage mandate by USA;
- IP52 ADS-B collaboration among States in SEA and BOB by Australia, Indonesia, Myanmar, the Philippines and Singapore

2.2 The Conference noted the encouraging progress of ADS-B implementation in the region, which was a regional priority item, and the positive results from the cost benefit analysis (CBA) presented by Singapore and CANSO. ICAO ANB highlighted the need for close coordination among States concerned in order to support reduction of separation minima to realize operational benefits.

2.3 In this connection, the Conference developed an Action Item for States/Administration to take follow-up action:

DP/3.3/8	Action Item 52/xx (12)	<b>ADS-B implementation Plans</b>  The Conference encouraged States with ADS-B implementation plans to explore ADS-B data sharing arrangements with their neighbors; and to expedite implementation of similar ADS-B collaboration over the areas of major traffic flows, remote and oceanic areas such as Bay of Bengal and the rest of the South China Sea.
