The **International Civil Aviation Organization (ICAO)** is a UN specialized agency, created in 1944 upon the signing of the *Convention on International Civil Aviation* (Chicago Convention).

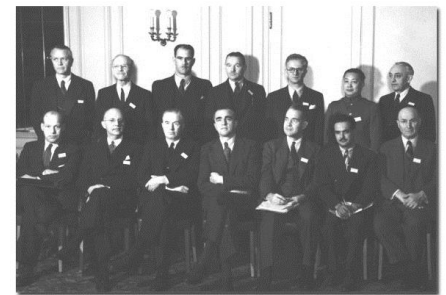
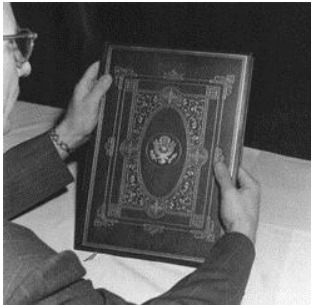




The **Chicago Convention** was signed on 7 December 1944

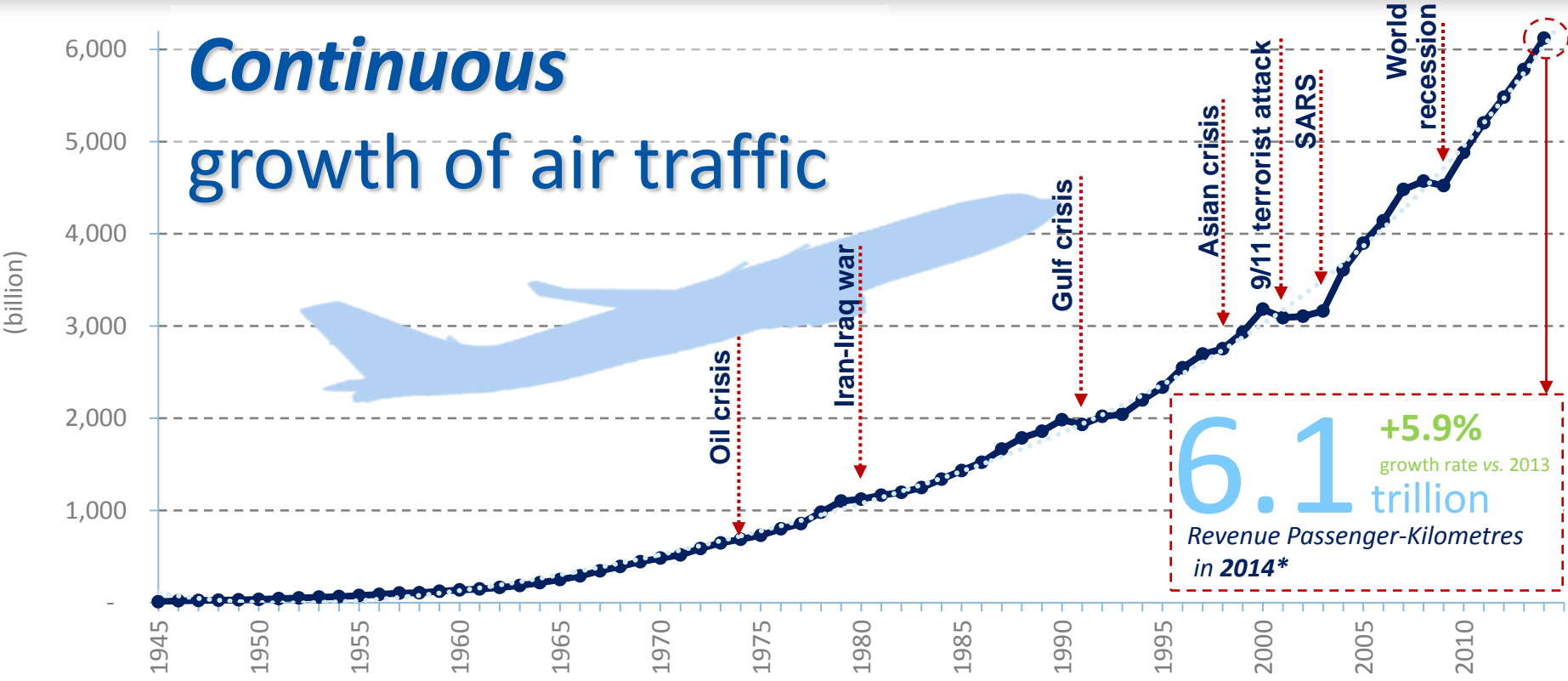


ICAO — Raison D'être

- The safe and orderly development of international civil aviation
- States work through ICAO to form agreements on the minimum Standards that must be met for safe, secure, efficient and “green” international aviation
- Nineteen Annexes to Chicago Convention
- Annex 18 — *The Safe Transport of Dangerous Goods by Air*

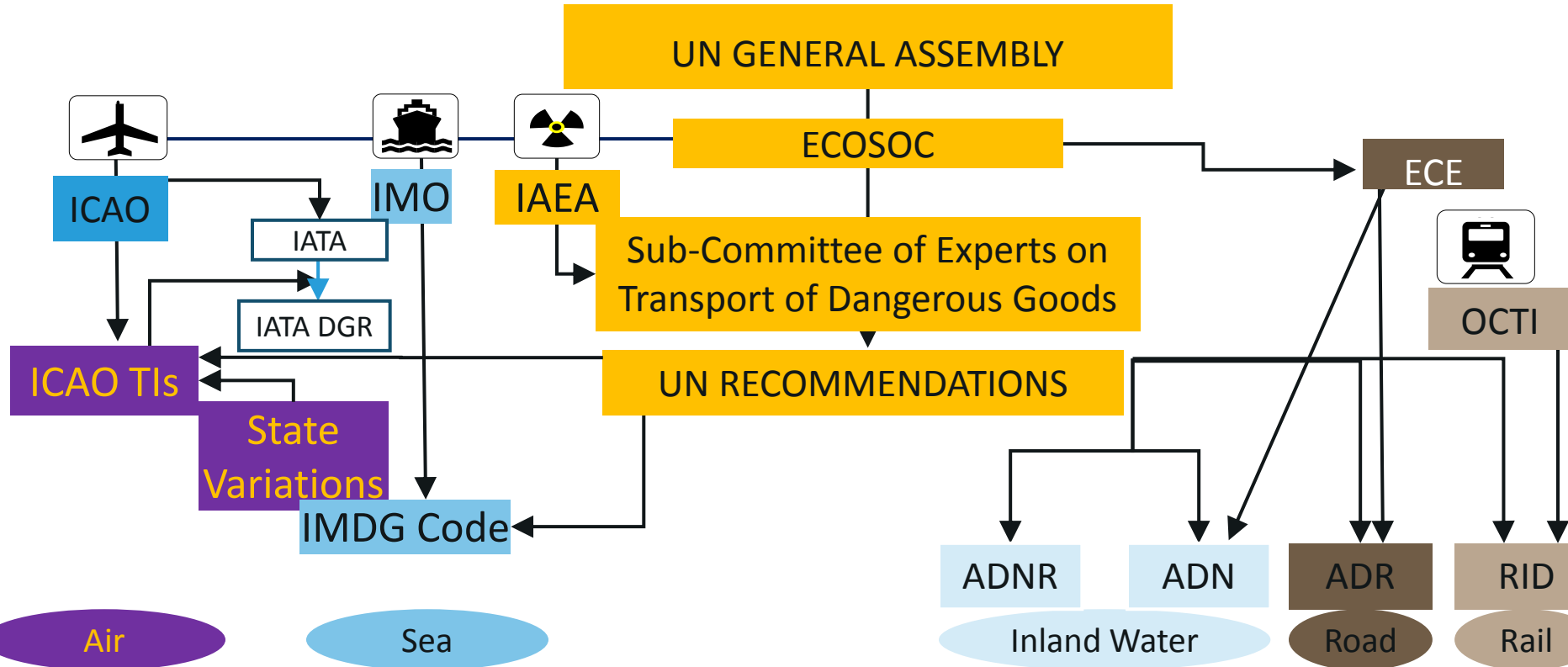


Why Rules are Necessary

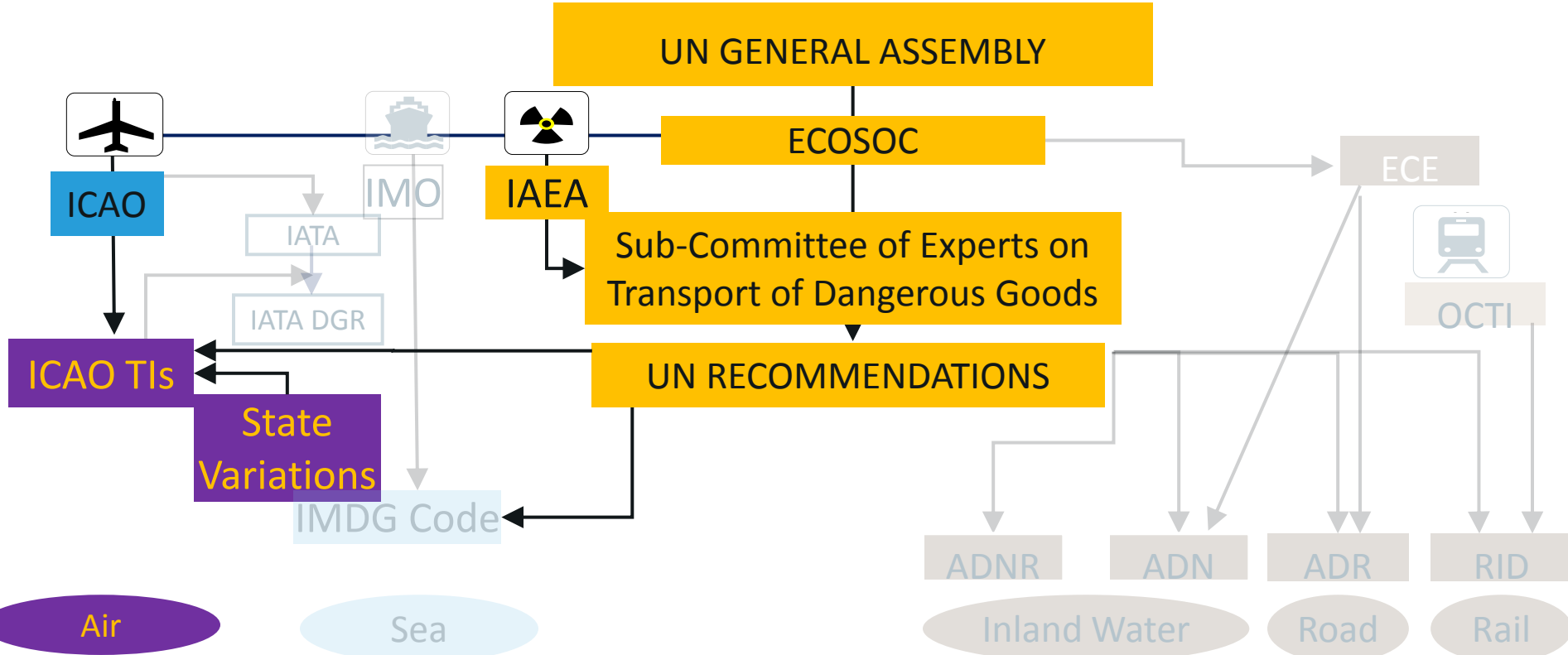
- 11 May 1996

Dangerous Goods Regulatory Framework

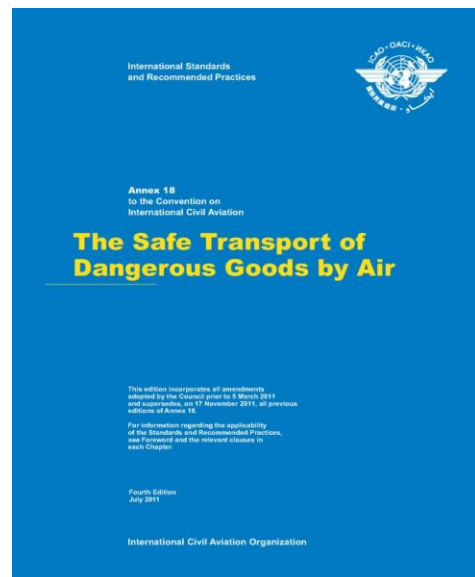


Dangerous Goods Regulatory Framework — Air Mode



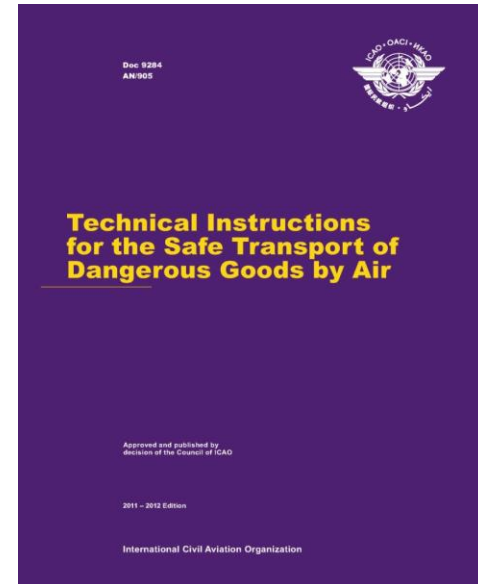
Annex 18

- The Safe Transport of Dangerous Goods by Air
 - “The Standards and Recommended Practices of this Annex shall be applicable to all international operations of civil aircraft.”
 - “Each Contracting State shall take the necessary measures to achieve compliance with the detailed provisions contained in the Technical Instructions.”



Technical Instructions

- Technical Instructions for the Safe Transport of Dangerous Goods by Air (Doc 9284)
- Issued every two years to reflect UN cycle
- Multimodal harmonization and facilitation aspects of transport





What's in the Instructions?

- Classification based on hazard
- Package = packaging plus contents
- Hazard communication
- Safety is at the package, not aircraft, level
- ICAO does not regulate manufacturers of goods consigned as cargo
