EXECUTIVE SUMMARY

This paper presents Report on the 3rd Meeting of the RASFALG-AFI meeting held in Nairobi, Kenya, 27 to 28 October 2016 and the RASFALG-AFI Indicative Work Plan 2016-2017

1. INTRODUCTION

The Third Meeting of the Regional Aviation Security and Facilitation Group for Africa and the Indian Ocean Region (RASFALG-AFI) was held in Nairobi Kenya from 27 to 28October 2016. The meeting was convened according to the approved Terms of Reference of the RASFALG-AFI.

2. PARTICIPATION:

The meeting was attended by Seventy eight (78) participants from 28 States, nine (8) International and Regional Organizations (CANSO, SITA, INTERPOL, AUC, CASSOA, AFCAC, ICAO, and IATA.

3. PRESENTATIONS

- 3.1. Nine presentations were made as follows:
 - a) Report on progress made on the 2nd RASFALG-AFI Recommendations AFCAC
 - b) Update on Designation of Technical Assistance Teams AFCAC
 - c) Enhancing Capacity Building through training ICAO
 - d) Action Plan on the implementation of the Windhoek Declaration and Targets ICAO
 - e) Recommendations/Decisions of SC3 ICAO
 - f) Report on Working Papers presented to the 39th ICAO Assembly AFCAC
 - g) Resolutions of A39 in the area of Aviation Security and Facilitation ICAO
 - h) Three major AFCAC meetings to be held in Botswana AFCAC
 - i) RASFALG AFI indicative WORK PLAN (2016-2017) AFCAC
- 3.2. The meeting noted implementation status of the 2nd RASFALG-AFI recommendations.
- 3.3. The meeting was informed of the current status of designation of technical experts by States and presented a list of technical experts registered in the AFCAC database. The meeting therefore, requested the Secretariat for the expeditious finalization of the experts list and submit to States for final consideration.
- 3.4. ICAO's initiative on the capacity building was discussed and the new Focus Area 6.
- 3.5. The meeting reviewed the draft Implementation Action Plan of the Windhoek Declaration and Targets and approved its submissions to the Air Transport Committee of AFCAC and AFI SECFAL Steering Committee.
- 3.6. Summaries of the Outcomes of the 39th ICAO Assembly were presented by AFCAC and ICAO. The meeting took note of the additional works to be undertaken in order to sensitize States to enhance effective implementations in this respect.
- 3.7. The meeting was informed about the consecutive meetings of AFCAC Air Transport Committee, Technical Committee and Extraordinary Plenary, to be held in Gaborone, Botswana from 7 to 11 November 2016.
- 3.8. The draft indicative work plan was presented to the meeting for consideration and was adopted with necessary adjustments. The meeting made substantive discussion and established time framed for the Indicative Work Plan and also noted that it will be updated and harmonized following the SC-AFISECFAL decision on the Implementation Action Plan of the Windhoek Declaration and Targets.
