#### 1. INTRODUCTION

- 1.1 The Africa-Indian Ocean Planning and Implementation Regional Group (APIRG) was established by the ICAO Council on 23 June 1981, and has held twenty (20) meetings since its inception. The APIRG is composed of all AFI Member States providing air navigation services in the Africa-Indian Ocean Region. International Organizations recognized by the Council as representing important civil aviation interests participate in its work in a consultative capacity.
- 1.2 This paper presents for adoption of the Provisional Agenda for the meeting, which was circulated with the invitation letter Ref. ES AN 1/6 0561 dated 28 July 2017, which was sent to AFI States/Administrations and International Organizations.
