#### 3.1 STATUS OF IMPLEMENTATION OF THE AFI eANP

## **SUMMARY**

This paper presents the progress achieved in the implementation of the new AFI eANP following the approval of the new template by APIRG/20 Meeting. It calls for States to contribute their inputs in a timely manner, once the Proposals for Amendments (PfA) of the AFI ANP related to Volumes II and III are circulated, to ensure accuracy of the data published.

### 1. INTRODUCTION

1.1 The 12th Air Navigation Conference (AN-Conf/12) agreed to Recommendation 6/1 regarding the alignment of regional air navigation plans (ANP) with the fourth Edition of the *Global* 

*Air Navigation Plan (GANP)* (Doc 9750). A new set of templates were developed for Volume I, II and III of the ANP and approved by the Council. In addition, new procedures for amendment of the ANP were developed and endorsed

1.2 The new AFI eANP template was approved by the APRG/20 Meeting (Yamoussoukro, Cote d'Ivoire, 30 November – 2 December 2015).

#### 2. DISCUSSION

- 2.1 The meeting will recall the action required under APIRG Conclusion 20/47: *Application and Development of the AFI eANP*, and following the circulation of a Proposal for Amendment of the AFI Air Navigation Plan (*PfA: ESAF-I 1601-AOP/CNS/ATM/MET/SAR/AIM*) on 4 July 2016 the President of ICAO, on behalf of the Council, approved on 19 August 2016. A copy of AFI eANP Volume I is at **Attachment A** to this working paper for reference.
- 2.2 Volume II has been updated with additional information following consultations between the two Regional Offices and the responsible Regional Programme Officer at ICAO Headquarters. The contents of Volume II (**Attachment B** to this working paper) have been reviewed and endorsed by the Air Navigation Bureau (ANB). Consequently, the ESAF Office has initiated and circulated a *Proposal for Amendment of the Air Navigation Plan* (PfA) of the New AFI eANP, for review and comments by States and organizations with a deadline of 20 October 2017, before final endorsement by APIRG (approval of Volume II is by regional agreement involving the relevant PIRG).
- 2.3 Volume III is currently under review and being coordinated by both ESAF and WACAF Regional Offices following which the updated draft will be posted online for comments by the Air Navigation Bureau before circulation to States. The amendment of Volume III would not require approval by the Council. The targeted date for finalization and endorsement of both Volumes II and III is December 2017.

#### 3. ACTION BY THE MEETING

- 3.1 The meeting is invited to:
  - a) note status of implementation of Volumes I, II and III of the AFI eANP;
  - b) urge States to review the PfA on Volume II and provide updates to ICAO ESAF and WACAF Regional Offices related to information published in the Tables therein, before 20 October 2017;
  - c) provide timely feedback to ICAO ESAF and WACAF Regional Offices on the PfA for Volume III, once circulated.
