- 1.1 In accordance with the generic Terms of Reference of PIRGs approved by the ICAO Council and in line with Decision C-DEC 210/4, the Africa-Indian Ocean Planning and Implementation Regional Group (APIRG) membership comprise all ICAO Contracting States, and Territories recognized by ICAO, within the area of accreditation of the ICAO ESAF and WACAF Regional Offices.
- 1.2 In addition to States, the importance of a collaborative and proactive role by airspace users, international and regional organizations, and industry is recognized due to their involvement in the rapid pace of technological development, expertise and other opportunities for sharing of resources.
