**Subject: Invitation - ICAO's Second iMPLEMENT Workshop in the ESAF Region
(Port Louis, Mauritius, 6-9 August 2019)**

Action required: Reply at your earliest convenience, preferably not later than **12 July 2019**

Sir/Madam,

1. I wish to inform you that ICAO is organizing ICAO's Second iMPLEMENT Workshop in the Eastern and Southern African (ESAF) Region, which will be held in Port Louis, Mauritius, from 6 to 9 August 2019.

2. The workshop covers the fundamentals of iMPLEMENT and related iSTARS applications; iMPLEMENT is a methodology conceived to facilitate data-driven decision making using a set of tools available on the iSTARS platform designed to help States with the implementation of ICAO's Standards and Recommended Practices (SARPs).

3. iMPLEMENT can be divided into three main steps, each of which uses a set of applications to obtain results:

1. the assessment of the current status and evaluation of the needs related to the aviation system;
2. the prioritization of problems and identification of the best solutions in order to maintain or improve the aviation capability of a State; and,
3. the identification of resources through existing planning tools and national, regional or global mechanisms.

4. The workshop is intended for all staff of State regulatory bodies (CAAs), safety managers and safety specialists who are involved in implementing ICAO's Standards and Recommended Practices (SARPs). We also encourage participation of staff of operators and the industry in your State (ANSPs, Airlines and Airport Operators).

5. The workshop will be conducted in English but the French speaking participants will feel free to elaborate and ask any question in French.

Taking into consideration the availability of documentation/presentations in electronic format, no hard copies will be distributed during the event.
