1 INTRODUCTION

- 1.1 The AFI Planning and Implementation Regional Group (APIRG) was established by the ICAO Council on 23 June 1981, and has held twenty-one (21) ordinary meetings and one (1) extra-ordinary meeting since its inception. In accordance with Council Decision (C-DEC 183/9) of 2008, the APIRG is composed of all ICAO Contracting States, who are service providers in the AFI Region and are part of the AFI ANP, and International Organizations which represent important civil aviation interests recognized by the ICAO Council, which participate in a consultative capacity.
- 1.2 The Africa-Indian Ocean Planning and Implementation Regional Group Projects Coordination Committee. Projects Coordination Committee (APCC) was established by APIRG/EO meeting held in Zambia in 2024 to undertake tasks that have hitherto been an increasing challenge. These include reducing the volume of material for consideration by APIRG meetings to manageable levels, carrying out certain tasks in between the APIRG meetings in order to facilitate continuity and efficiency in implementation, and supporting the required coordination between APIRG and RSG-AFI. The APCC is composed of elected Chairperson and Vice-chairperson, the Secretary of APIRG, elected Officials from States and Secretaries of the Sub-Groups
- 1.3 This paper presents for adoption the Provisional Agenda for the meeting, which was circulated, to APCC members with the invitation letter Ref. ES AN 1/6–0316 dated 23 October 2020.

2. DISCUSSION

- 2.1. The Provisional Agenda for APCC/5 was prepared by the Secretariat in line with the Air Navigation Commission's recommendation for a uniform approach to the formulation of the agenda for Planning and Implementation Regional Group (PIRG) and its subsidiaries Meetings, following consultation between the APIRG Chair and the ICAO ESAF and WACAF Regional Offices.
