The ICAO State Letters on Council Aviation Recovery Task Force (CART) and Take-off Guidance for Air Travel through the COVID-19 Public Health Crisis

- CART Phase I SL 2020/067, 8 June 2020
 - **11 Recommendations** (REC-1 to REC-11)
 - Take-off Guidance for Air Travel through the COVID-19 Public Health Crisis (TOGD)

CART Phase III - SL 2021/21, 17 March 2021

- **REC -12 Revised:** Aviation Safety related Measures
- **REC -14 Revised:** Public Health Corridors (PHCs)
- <u>REC -15</u>: Safe Cargo Transport Implement (Doc 9284) transport of COVID-19 vaccines and certain dangerous goods to be carried on board aircraft.
- <u>REC-16</u>: Facilitating Air Cargo Movement Temporary lifting of restrictions to air cargo operations to facilitate the transportation of essential goods, supplies and COVID-19 vaccines.



CART Phase III - SL 2021/21, 17 March 2021


- <u>REC-17</u>: Testing Certificates Implement testing certificates based on Manual on Testing and Cross-Border Risk Management Measures (Doc 10152) to facilitate air travel.
- → <u>REC-18</u>: Vaccination Facilitate <u>access for air crew to vaccination</u> as per WHO provisions.
- <u>REC-19</u>: Vaccination <u>should not</u> be a prerequisite for international travel until scientific or medical evidence demonstrates otherwise.
- REC -20: Communication Ensure ICAO's CART guidance is taken into consideration by the wider State Administration in the decision-making processes on national recovery planning.



States Recovery Stages – ESAF and WACAF Status (as of 4 June 2021)


The recovery stage is based on an algorithm developed using traffic data, COVID data as well as data from the CRRIC.



- Stage 0: A situation with travel restrictions and only minimal movement of passengers between major domestic and international airports.
- Stage 1: Initial increase of passenger travel with relatively low passenger volumes, allowing airlines and airports to introduce aviation public health practices appropriate to the volume.
- Stage 2: Passenger volumes will continue to increase. Several measures that were required in Stages 0 and 1 may be lifted.
- Stage 3: May occur when the virus outbreak has been sufficiently contained in a critical mass of major destinations worldwide as determined by health authorities. The reduction of national health alert levels and associated loosening of travel restrictions will be key triggers. Risk mitigation measures will continue to be reduced, modified, or will be stopped in this stage. There may not be effective pharmaceutical interventions (e.g. therapies or vaccines) commonly available during Stage 3, but contact tracing and testing should be readily available.
- Stage 4: Begins when specific and effective pharmaceutical interventions readily available in most countries. There may be a set of residual measures/mitigations that could be retained, although these too should undergo a periodic review process.



States Recovery Stages – ESAF and WACAF Status (as of 4 June 2021)








GAP Analysis – Reporting Status by CART Phase (as of 4 June 2021)






GAP Analysis Status of CART Recommendations - ESAF States (as of 4 June 2021)



4 ESAF States are yet to review 45% or more of the recommendations → Djibouti, Eritra, Lesotho, Madagascar




GAP Analysis Status of CART Recommendations - WACAF States (as of 4 June 2021)






Public Health Risk Mitigation Measures Level of adoption – ESAF States (as of 4 June 2021)



- On average, **ESAF** States have **reported as adopted 81.8%** of PH measures.
 - On average, ESAF States have not reviewed 10.7% of the measures.



Public Health Risk Mitigation Measures Level of adoption – WACAF States (as of 4 June 2021)



- On average, WACAF States have reported as adopted 77% of PH measures.
 - On average, WACAF States have not reviewed 14.1% of the measures.



State Testing and Quarantine Protocols application (as of 4 June 2021)

The application was established using the data collected by ICAO through a **SURVEY ON COVID-19 TESTING AND CROSS-BORDER RISK MANAGEMENT MEASURES** under **State letter AN 5/28-21/8 dated 29 January 2021**, conducted by the Aviation Medicine Section.

Targeted Exemptions (TEs)

- ICAO State letter 2021/27 End of the CCRD system for recording differences related to the COVID-19 pandemic, and establishment of the Targeted Exemptions system for exceptional circumstances, dated 31 March 2021.
- TE system launched to support States in the transition to normal operations, replacing the CCRD system with transition period from 1 April 2021 to 30 June 2021. In the event of unforeseeable circumstances, validity of TEs may extend beyond 30 June 2021. However, appropriate mitigation measures MUST be put place.



Targeted Exemptions (TEs) - States that have not submitted TE Acceptability Form

- As at 4 June 2021, 21 WACAF States (constituting 88%) and 16 ESAF States (constituting 67%) have submitted the TE Acceptability Form to ICAO.
- All States urged to complete and **submit the TE Acceptability Form**.



 - Bundle of **guidance material, training, tools, expert** assistance and, when applicable, procurement guidance
 - Aims at facilitating and guiding the implementation of the applicable ICAO provisions and recommendations by State entities (e.g. Governments, Civil Aviation Authorities and National Air Transport Facilitation Committees), aviation service providers, supply chain stakeholders and their personnel. <u>http://www.icao.int/iPACK</u>





States are urged to

- Report the status of implementation of CART recommendations, particularly those of CART II and III.
- → Validate and continously update the Travel Protocols in the CRRIC
- → Recall that Target Exemption (TE) system is established for exceptional circumstances to support the transition to normal operations for the period from 1 April 2021 to 30 June 2021
- → Inform ICAO of any TEs granted by using relevant TE submission forms and Submit/update TE acceptability as soon as possible (<u>https://www.icao.int/safety/OPS/OPS-Normal/Pages/TEAcceptability.aspx</u>)
- → Report challenges faced on the restart of commercial air transport, including on the implementation of CART recommendations and Public Healh Measures



States are urged to

- Endeavour to return to normal aviation operations as soon as possible unless circumstances dictate otherwise.
- → Assess and mitigate risks associated with exemptions from regulatory requirements.
- → Share experiences with other States regarding the TEs granted and associated mitigation measures.
- → Request assistance from the ICAO Regional Offices, as necessary
