
1. Introduction

1.1 The MIDANPIRG/13 meeting was held in Abu Dhabi, from 22 to 26 April 2012. The meeting was attended by a total of one hundred and two (102) participants, which included experts from ten (10) States (Bahrain, Egypt, Iran, Jordan, Kuwait, Oman, Qatar, Saudi Arabia, UAE and Yemen) and six (6) International Organizations/Agencies (ACAC, CANSO, IATA, IFALPA, Jeppesen and MIDRMA).

2. DISCUSSION

- 2.1 The meeting may wish to recall that Flight Plan Implementation Tracking System (FITS) website at http://www2.icao.int/en/FITS/Pages/home.aspx, provides information regarding the implementation status of the new flight plan provisions for each State along with guidance and harmonized solutions to any difficulties encountered in the implementation. The FITS has been updated with latest information regarding the MID Region.
- 2.2 The MIDANPIRG/13 meeting urged MID States to provide progress report as requested by MIDANPIRG/12 Conclusion 12/55, in order to reflect in FITS and since changes are likely to occur rapidly as the due date of the applicability is nearing, the meeting agreed that progress reports should be provided to ICAO MID Regional Office on monthly basis.
- 2.3 The MIDANPIRG/13 meeting reviewed and updated the status of INFPL implementation, and secretariat reflected the updates in the FITS as at **Appendix A** to this working paper.

2.4 The meeting may wish to note that ICAO HQ and regional office conduct regular teleconference in order to discuss the progress of INFPL Implementation in all States and reflect updates in the FITS to enable the aviation community to be aware of the progress in a transparent manner. In this respect it was agreed during the teleconferences to adopt the following color coding in the FITS:



2.5 The green color will be reflected only when the State issues official notification of their readiness either via AIC, or NOTAM and send a copy to the ICAO Regional Offices who in turn will update the FITs accordingly.
