1. INTRODUCTION

1.1 The Region Air Navigation Strategy endorsed by MIDANPIRG/15 as MID Doc 002 as the framework identifying the regional air navigation priorities, performance indicators and targets. The B0-FICE is one of the twelve priority 1 ASBU Modules that need to be implemented in the MID Region also it is global priority.

2. DISCUSSION

2.1 The MIDANPIRG/15 meeting noted that the MID Region Strategy for the implementation of AIDC/OLDI contained a combination of guidance, focal points, planning and implementation materials. The meeting reviewed and updated the list of AIDC/OLDI Focal Points at **Appendix A**.

2.2 The status of implementation of the B0-FICE as at **Appendix B** and it was agreed by MIDANPIRG/15 to include it in Volume III of the MID eANP. It was highlighted that the CNS SG is the main Regional monitoring body for the collection of data related to the B0-FICE implementation in the MID Region.

2.3 For an improved consistency, and considering that the MID Air Navigation Strategy and the MID eANP Volume III include the ASBU Block 0 Module B0-FICE. Accordingly, the MIDANPIRG/15 meeting agreed to the following Conclusion:

CONCLUSION 15/18: MID REGIONAL GUIDANCE FOR IMPLEMENTATION OF AIDC/OLDI

That, the MID Region guidance for the implementation of AIDC/OLDI (Edition 1.1, June 2015) is endorsed as MID Doc 006.

2.4 The meeting may wish to note that the ICAO AFI/MID ASBU Implementation workshop was conducted 23-26 November 2015, received a presentation on the B0-FICE. The workshop emphasized on the harmonization of AIDC/OLDI procedures for interregional coordination between interface ATSUs.

2.5 Furthermore, the workshop also noted the additional benefits gained by UAE from the Implementation of OLDI included the following:

- No manual intervention for flights between OLDI partners
- Reduction in coordination failures
- Elimination of human errors
- Better management of SSR codes by automatic allocation of SSR code from a centralised SSR pool
- Up to 90% reduction in telephone calls
- Efficient work prioritisation for Flight Data Operators

3.1 The meeting is invited to:

- a) update the AIDC/OLDI Focal Points and the Implementation Status at **Appendices A** and **B**, respectively;
- b) encourage States to benefit from guidance provided in the MID Doc 006;

- d) urge States to sign LOA for the AIDC/OLDI Implementation;
