**TERMS OF REFERENCE**

**THE TERMS OF REFERENCE OF THE MIDRMA BOARD ARE AS FOLLOWS:**

1. The Board is responsible for overall supervision, direction, and management of the MIDRMA project.
2. The Board shall elect a Chairperson.
3. The elected Chairperson acts as the contact point/coordinator on behalf of the MID RMA Board members to oversee the MIDRMA project in coordination with ICAO.
4. The Board shall review and update the MIDRMA work plan on a yearly basis and/or whenever required.
5. The Board shall meet at least once a year or when deemed necessary to review/update, consider, and approve:
  - i. the MIDRMA safety reports;
  - ii. matters related to funding mechanism, costs, accounting, etc; and
  - iii. the duties, responsibilities and scope of the MIDRMA.
6. The MIDRMA Board meetings should be hosted by Participating States on rotation basis.
7. The Board reports its activity to MIDANPIRG through the ATM/SAR/AIS Sub-Group.

**COMPOSITION:**

The MIDRMA Board shall consist of focal points nominated by each Participating MID Region State as signatories on their behalf with ICAO Technical Cooperation Bureau (TCB) in relation with the MIDRMA project.

The MIDRMA Board meetings will be attended by:

- The Board Members;
- ICAO Regional Office, as permanent observer; and
- Other Organizations (EUROCONTROL, IATA, etc.) as observes on ad-hoc basis and as required.

## 9. CURRENCY, CREDIT CARDS AND BANKING SERVICES

9.1 The unit of currency in Sudan is the **Sudanese Pound (SDG)**. Current rate of exchange for US \$ is US \$ 1 = 6.7SP approximately.

9.2 The foreign currency more than 10000 US \$ should be declared.

9.3 International Credit Cards, such as American Express, Diners Club, Visa, Master Charge, Carte Blanche, etc. **are not accepted**. Participants should bring enough cash to cover for their expenses.

9.4 All commercial banks exchange major foreign currencies and are open from 0900 to 1400 hours Sundays through Thursdays.

9.5 Some commercial banks exchange major foreign currencies and are open from 1800 to 2100 hours.

## 10. OTHER USEFUL INFORMATION

### SHOPPING

10.1 Shopping areas are available in Sudan. Be prepared to bargain in small shops, sidewalk vendors etc. In large stores, however, the prices are fixed.

### TAP WATER

10.2 It is recommended that all visitors drink only bottled water/beverages.



## **11. WEATHER CONDITIONS**

11.1 The main daily minimum and maximum temperatures for the month of February in Sudan are between 25°C and 35°C.
