### **Objective**

This presentation addresses the Strategy and Roadmap for improvement of aviation safety in the MENA States by enabling States to conduct effective and independent investigations of aircraft accidents and incidents; and support States in fulfilling their investigation obligations in Annex 13.







### **Historical Background**

A new Strategy was requested by ACAC/ICAO AIG Workshop (Jeddah 25-27 April 2017) 6 States + ICAO HQ + ICAO MID

Accordingly, an ad-hoc working group was formed



The New Strategy

Modified version

Three Levels of States

Movement from one Level to the next depends on the willingness of the State and its performance

States to be minimum at Level 2

The Old Strategy

Difficult to be implemented

Required the States to collectively move from a phase to next

No sufficient consideration to the variation among States' capabilities







### The New Strategy

Level 1

Annex 13 standard bilateral MoU among MENA States. At least on: Resources, training, information, and capabilities



Level 2

Regional cooperation mechanism (Set of coordinated, organized, and harmonized procedures and mechanisms)



Level 3

Establishment of a RAIO with:

Mandate, roles and responsibilities, organization (human resources), funding mechanism, etc.

With a centralized decision-making process on RAIO activities







### Roadmap

- A Roadmap for the implementation of Strategy is developed under the framework of RASG-MID
- Provides the details for implementation of the different Levels by main action points
- KPIs for monitoring the implementation
- Decisions are taken based on achievement goals, after States discussion/evaluation


