I wish to invite you to the Joint ACAO/ICAO Global Air Navigation Plan Aviation System Block Upgrades (ASBU) Symposium for EUR/NAT and MID Regions to be held in **Marrakech**, **Morocco**, **from 10 to 13 December 2018**. The Symposium will be organized jointly by the ICAO EUR/NAT and MID Regional Offices; and hosted by the Arab Civil Aviation Organisation (ACAO).

The objective of the Symposium is to raise awareness on the latest global air navigation developments, including the outcome of the 13th Air Navigation Conference (AN-Conf/13), review the status of implementation of the ASBU Modules and address associated challenges based on lessons learned and best practices. The Symposium will also provide an opportunity to explore ways and means to support the implementation of the agreed air navigation priorities taking into consideration airspace users' requirements, fleet equipage, infrastructure, interoperability and inter-regional coordination, and address the Regional and National planning for ASBU implementation.


