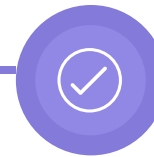
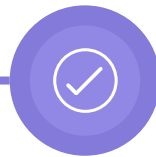

Preparation for eliminating Old NOTAM

#1

UAE NOTAM Office constantly strives to keep all issued NOTAM under 3 months duration.

#2

Tracking System is developed to monitor NOTAM that exceed 3 months.

#3

Guidance Procedures for Long Term NOTAM are laid down for both the NOTAM Office & Data Originators in coordination with the Regulator.

#4

Periodic meetings with all Data Originators are held.





Actions

#1

If NOTAM Requests are for more than 3 months, Data originators are advised that NOTAM will be issued as EST NOTAM for 3 months only and replaced with an AIP Supplement in next planned publication.

#2

If the validity of a NOTAM unexpectedly exceeds 3 months, Data originators are advised that a maximum 2 months extension can be provided and will be replaced with an AIP Supplement in next planned publication.

#3

If Data Originator request for further extension above the additional 2 months, they are advised to get Regulator approval.
