



## Southern Interface with ICAO MID Region



- Athens FIR/Hellas UIR Cairo FIR:
  - No issues and no interface airspace developments planned or proposed.
  - Currently one traffic flow rule (restriction) exists over KUMBI on LoA request by Cairo ACC.
  - Hellas FRA (FL305 FL660) will be expanded from Night to H24 as from 23 MAR 2023.
- Nicosia FIR Cairo FIR:
  - No issues and no interface airspace developments planned or proposed.
  - Currently no traffic flow rules (restrictions) other than imposed inside Nicosia FIR.
  - FRANIC (FL205 FL660) at Night 21:30 04:30 (20:30 03:30) will be implemented as from 23 MAR 2023.
- Tel Aviv FIR Cairo FIR:
  - No issues and no interface airspace developments planned or proposed.





- Tel Aviv FIR Amman FIR:
  - No issues but interface airspace developments continue for the benefit of the AOs.
  - Currently no traffic flow rules (restrictions) other than imposed inside Tel Aviv FIR but not impacting traffic via Amman FIR.
  - For FWC2022 ATS routes within Tel Aviv FIR will be available H24 from 10 NOV 2022 till 25 DEC 2022 with very short break (see next slide).
  - ATS routes in Amman FIR are already available H24.

LL NOTAM A0986/22 was replaced and overflights will not be available only on 30 NOV BTN 15:00 - 19:30UTC BTN FL325 - FL600.

- Nicosia FIR Beirut FIR:
  - No issues and no interface airspace developments planned or proposed.
  - Currently no traffic flow rules (restrictions) other than imposed inside Nicosia FIR.
- Nicosia FIR Damascus FIR:
  - Interface unavailable.

### North Eastern Interface with ICAO MID Region



- Ankara FIR Damascus FIR:
  - Interface unavailable.
- Ankara FIR Baghdad FIR:
  - No issues and no interface airspace developments planned or proposed.
  - Currently no traffic flow rules (restrictions) other than imposed inside Ankara FIR.
  - EUROCONTROL still believes that better and equal traffic distribution over KABAN and NINVA can be achieved. Vision already presented by EUROCONTROL.
- Ankara FIR Tehran FIR:
  - Traffic Orientation Scheme (TOS) within Tehran FIR exists from 14 JUL 2022 till 13 JUL 2023. This standard and mandatory TOS is published to enable all aircraft operators, planning to fly within the OIIX FIR (including transit, domestic and international departure and arrival) to file flight plans as required by Tehran ATS.
  - Currently traffic flow rules (restrictions) are imposed also inside Ankara FIR due to the Iranian TOS.
  - EUROCONTROL still believes that TOS might be reconsidered due to not so high traffic demand at that interface.
  - Interface airspace improvement proposals exist in ICAO EUR RDGE Route Catalogue (see Slide 10).





- Yerevan FIR Tehran FIR:
  - No issues and interface airspace improvement proposals exist in ICAO EUR RDGE Route Catalogue (see Slide 10).
- Baku FIR Tehran FIR:
  - No issues and interface airspace improvement proposals exist in ICAO EUR RDGE Route Catalogue (see Slide 10).
