In this regard, I wish to recall the Long-Term Aspirational Goal (LTAG) for international aviation of net-zero carbon emissions by 2050 adopted by the 41st ICAO Assembly (Resolution A41-21) as well as the ICAO Global Framework for Sustainable Aviation Fuels (SAF), Lower Carbon Aviation Fuels (LCAF) and other Aviation Cleaner Energies adopted during the Third ICAO Conference on Aviation and Alternative Fuels (CAAF/3).
