SCHEDULE FOR CONSIDERATION OF AGENDA ITEMS

1. In order to facilitate coordination in the conduct of the business of the Assembly, a suggested schedule for consideration of agenda items has been prepared. The schedule is presented overleaf.
2. The numbers shown on the chart are those of the agenda items appearing in A35-WP/1 P/1. With respect to the Plenary meetings contemplated for Friday, 8 October 2004 to consider reports from the Executive Committee and Commissions as they become available, attention is called to A35-WP/4 P/4.
3. The letter “R” preceding an agenda item number on the schedule indicates approval of the report on that agenda item by the Executive Committee or Commissions. Changes in the schedule will also be required if the Assembly adds or deletes items to those appearing in A35-WP/1 P/1.
4. The opening of the First Plenary Meeting will be held on Tuesday, 28 September 2004, at 1100 hours in the Assembly Hall and will be preceded by an informal meeting of Heads of Delegations of Contracting States, starting at 0945 hours. The working hours of the Assembly will be from 0930 to 1230 hours and from 1430 to 1700 hours.
