<u>Art. 10</u>: Aircraft to land at <u>designated</u> *customs* airport for customs & other examination

<u>Art. 13</u>: Passengers, crew, cargo: compliance with laws on *entry, clearance, immigration, passports, customs, quarantine*

<u>Art. 14</u>: State to take measures to prevent the *spread of disease*



Article 37

(Adoption of International Standards and Procedures)

1.Each State undertakes to collaborate in securing . . uniformity . . . in regulations, standards . . . in all matters in which such uniformity will facilitate & improve air navigation.

2.ICAO required to adopt SARPs . . .

- (j) Customs & immigration procedures . . .

& such other matters concerned with the . . . regularity & efficiency of air navigation . . .

Annex 9 developed:

→ elaborate States' obligations under Articles 22, 23, 24

→ standardize procedures for meeting legal requirements under Articles 10, 13, 14, 29, 35



- FAL Division 1 11: Amendments to Annex 9
- Divisions to 1979: 4-6 years gap; thereafter: 7-9 years
- FAL/11 (1995): time lapse not conducive to keep up with technical & other developments
- Recommendation on FALP

→ examine policy issues & develop recommendations for FAL Division or ATC/Council

ANNEX 9: "SARPs" MEANING -Standard

Any specification, the **uniform observance** of which has been recognized as practicable and as necessary to facilitate and improve some aspect of international air navigation, which has been adopted by the Council pursuant to Article 54 (I) . . , and in respect of which non**compliance must be notified** by Contracting States . . . in accordance with Article 38.



– Recommended Practice

Any specification, the **observance** of which has been recognized as generally practicable and as highly desirable to facilitate and improve some aspect of international air navigation, which has been adopted by the Council pursuant to Article 54 (I) . . ., and to which Contracting States will endeavour to conform in accordance with the Convention.



C. ANNEX 9: AMENDMENT PROCESS

- <u>Art. 37</u>: ICAO required to adopt and amend, from time-to-time, SARPs . . . (j) Customs & immigration procedures . . .
- <u>Art. 54</u>(*Mandatory functions of Council*) The Council shall:
 →(I) Adopt SARPs . . .(Annexes) . . . notify States of action taken
 →(m) Consider recommendations for amendments
- <u>Art. 90</u>: 2/3rds vote; effective 3 months after submission to States unless majority disapprove




Article 38: *Departures from international standards and procedures*
