PIRG-RASG Global Coordination Meeting, Montreal, 19 March 2013



- Each RASG will be different according to region
- Coordination based on global objectives and plans, avoiding duplication of efforts, ensuring efficiencies and consistency is needed
- Coordination is the ICAO Secretariat responsibility
- MQs should play a role in coordination
- Decide which ANB section (ISM, OPS, or ISD) provides HQ support to ROs and define the coordination role – suggest OPS Section



Consider establishment of a RASG Board (not a new office nor positions)

- Role: High-level strategy/policy/monitoring group
- Suggested composition: RASG Secretaries + other RDs + D/ANB + ISM, OPS, and/or ISD Section Chiefs

Would meet only as necessary – similar to MARB



Consider establishment of a RASG Committee

Role: Operational level tactical coordination work programme approach & methodology, performance metrics, best practices


Suggested composition: Appropriate ANB and RO officers + industry representatives + CAST + ECAST

Example activities: periodic telcons, sharing info on initiatives and lessons learned, etc.
