2. **DOCUMENTATION**

2.1 An Order of Business (STA/10-O/B-2) has been issued for the Closing Plenary.

2.2 The 10th Statistics Division Meeting welcomed 132 delegates from 50 ICAO Member States and six organizations with observer status to ICAO as will be reflected in the final report.

3. PROCEEDINGS ON 26 NOVEMBER 2009

3.1 Morning session

3.1.1 The Division reviewed and adopted the Draft Reports on Agenda Items 8, 9, 10, and 11.

3.1.2 Deliberations of Agenda item 12 — Collection, Analysis and Dissemination took place on the basis of the following working papers, listed in the order in which they were presented by the Secretariat: WP/24 — Review of the Current Reporting Status: Commercial air Carriers, and WP/25 — Review of the Current Reporting Status: Airports and Air Navigation Service Providers (ANSPs).

3.1.3 Deliberations of Agenda item 13 — Cooperation and Coordination with other Organizations were carried out based on WP/26 — Coordination of ICAO's Statistics Programme with those of other Civil Aviation Organizations.

3.1.4 Deliberations of Agenda item 14 — ICAO Strategic Objectives and Associated Metrics were carried out on the basis of WP/30 — Review of the Different Key Performance Indicators.

3.1.5 Deliberations of Agenda item 15 — Other Matters and Administrative Issues Regarding the ICAO Statistics Programme were carried out on the basis of WP/27 — Impact of Reporting of Air Carrier Financial Data on Traffic Forecasts — Other Issues, WP/28 — Added Value of the New Data Collection in Terms of Revenue Generation, and WP/29 — Other Matters and Administrative Issues regarding the ICAO Statistics Programme.

3.2 Afternoon session

3.2.1 The Report of the Working Group (WG2) on a New Data Collection of Fuel Consumption by Commercial Air Carriers was presented.

3.2.2 Deliberations of Agenda item 12 — Collection, Analysis and Dissemination, continued on the basis of WP/32 — Calidad de la Informacíon Estadística (Spanish only).

3.2.3 Deliberations of Agenda item 15 — Other Matters and Administrative Issues Regarding the ICAO Statistics Programme continued in order to consider WP/34 — Necesidad de información sobre el origen y destino real del tràfico (Spanish only).
