


External interoperability with other national/regional systems

## **INTERPOL Travel Document Screening Tool**





#### ... now populated via INTERPOL I-Link Web Services








## The SLTD database



## **Interoperability with national API systems**

Persons seeking to utilize lost or stolen passports, to facilitate illicit travel, may be more easily identified prior to travel, where the receiving government also compares travel document information contained in the API messages with the INTERPOL SLTD databases.

Same consideration is valid for wanted persons that can be easily identified, located and eventually arrested by cross-checking information contained on API data against INTERPOL Nominal database.

- To implement "READY TO INTEGRATE" FIND solutions accessing :
  - National
  - Regional (when exists)
  - International databases
- To implement WISDM SLTD for populating automatically INTERPOL databases from national repository.
- To integrate INTERPOL FIND Web Services into Border Management Solutions (Solution Providers)
- To screen SYSTEMATICALLY and AUTOMATICALLY ALL passengers
- INTERPOL is ready to API/PNR
- Evisa project can be easily integrated
