CAPSCA activities prior to the pandemic



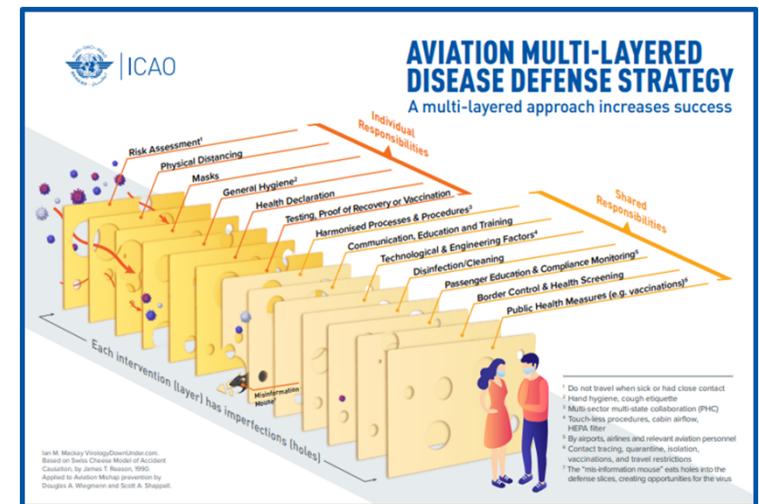

CART and Manual on Testing and COVID-19 Cross-border Risk Management

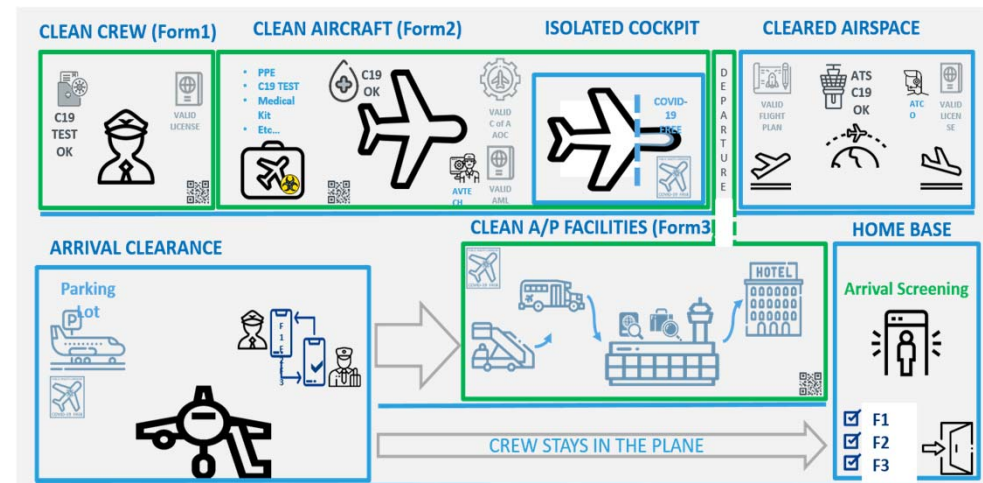
- Several working groups
 - CART TOGD e.g. disinfection, masks, layovers, hazardous waste, etc.
 - Manual
 - CASAG (CAPSCA Scientific Advisory Group)
- Manual contents
 - Risk management and epidemiology
 - Testing, vaccination and quarantine
 - Vaccination
 - Multi-layer risk tool
 - Public Health Corridor
 - Transitioning to routine operations
- **Currently activities include:**
 - **updating risk indicators for different phases**
 - **evaluating effectiveness of measures**
 - **criteria for the de-escalation/ escalation of mitigation measures**



During pandemic

Public Health Corridor Concept

- Continued flight operations with minimal restrictions
- Maintain safety management principles
- Mitigate the spread of COVID-19
- Health and safety of crew and passengers
- Coordinated global approach
- Harmonized procedures and requirements
- Consult with all relevant stakeholders
- **Continue to refine parameters & methodology**



During pandemic

CAPSCA Global Symposium: discussion of HLCC recommendations

- Collaboration - all stakeholders at all levels
- Standardization between states
- Considering state sovereignty
- **Governance and strengthening of CAPSCA**
- **Develop comprehensive framework for significant public health emergencies**

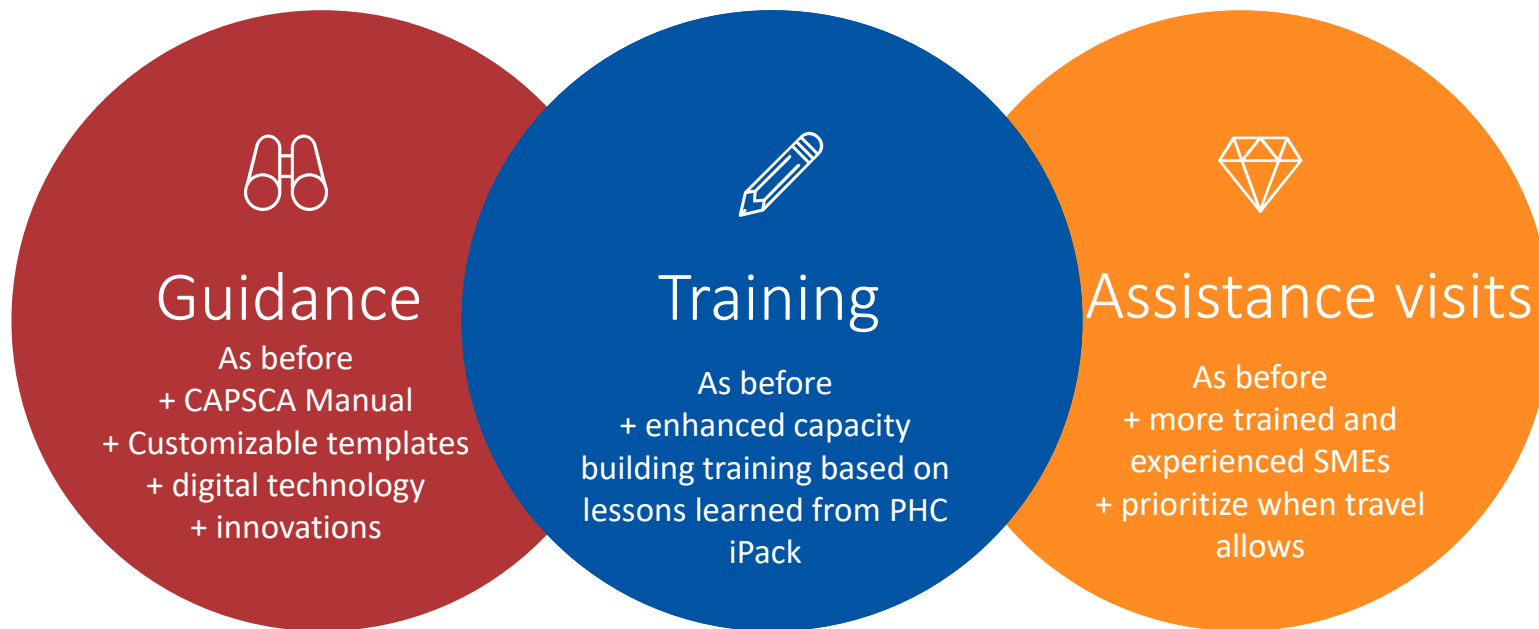
Ongoing projects

PHC iPack

- Goal: Restore international travel
- Includes:
 - additional training courses and workshops
 - tools include checklists, frameworks, decision aids, templates
 - customized state workshops
 - practice with the PHC Arrangement App
- Progress - 12 iPacks, involving 25 States
- **Current review of iPack:**
 - **in view of lessons learned**
 - **expand capacity building for any future public health emergency**
 - **retain PHC component**

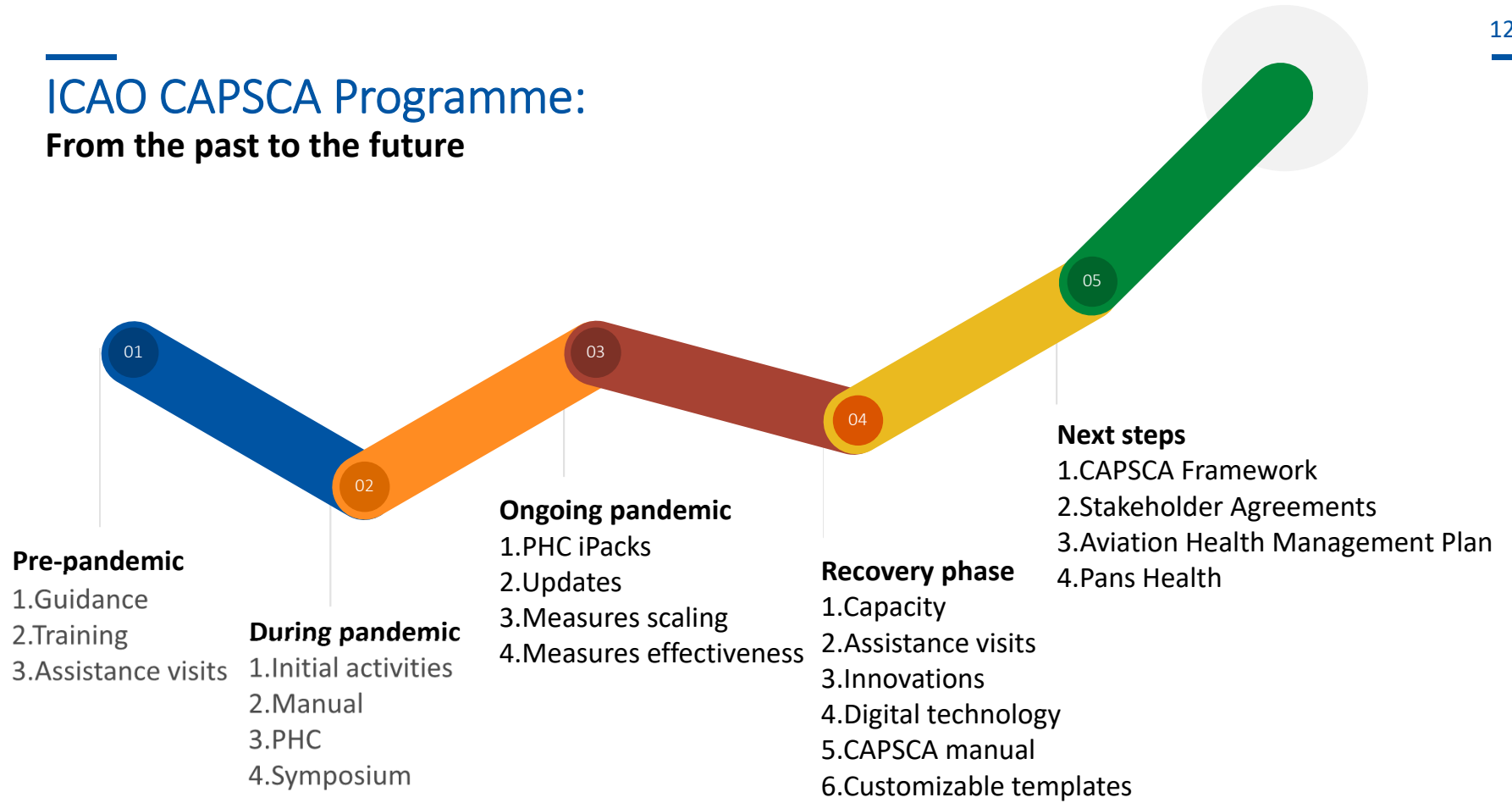
