Border Security and Management (BSM) UN Global Counter-Terrorism Strategy


The UN Global Counter-Terrorism Strategy is a unique global instrument to enhance national, regional and international efforts to counter-terrorism. Adopted in 2006, all UN Member States agreed for the first time to a common strategic and operational approach to fighting terrorism.

The Strategy sends a clear message that terrorism is unacceptable in all its forms and expressions and takes practical steps to prevent and combat terrorism.

Those reasonable steps include measures ranging from strengthening state capacity to counter terrorist threats to better coordinating the UN System's counter-terrorism activities

Programme Mandate and Objectives

The UN Security Council emphasized the importance of addressing issues relating to BSM as a key component in countering terrorism and stemming the flow of FTFs through resolutions 1373 (2001), 1540 (2004), 2178 (2014), 2309 (2016), 2322 (2016), 2396 (2017), and 2482 (2019)

- Providing thematic expertise to Member States, regional and/or sub-regional bodies in developing and implementing comprehensive border management strategies and action plans which incorporate counter-terrorism measures and FTF elements
- Enhancing the capacities of Member States to address challenges and emerging threats within all modes of cross-border transportation
- Development and dissemination of reference material and guidance tools including modules on crossborder travel cycle pertaining to air, maritime, rail and bus travel relating to both people and cargo
- Promotion and incorporation of Gender and Human Rights dimensions
- Sustainability through leveraging partnerships with training institutions; national ownership; Curicula development; ToT programming and ongoing mentoring


