#### 1. LOCATION

The ICAOTRIP Seminar will be held at the **Kish International Convention Center, Persian Gulf Auditorium, Sahel Blvd., Kish Island, I.R. of Iran,** from 9 to 11 May 2016. The meeting will be hosted by Civil Aviation Organization of the Islamic Republic of Iran (CAO.IRI).

## 2. SCHEDULE OF THE MEETING

Official opening session of the Seminar will commence at 0900 hours on Monday, 9 May 2016; the Seminar will be conducted in English with simultaneous translation in Persian.

## PASSPORT/VISA

## **8.** CUSTOMS FORMALITIES

## **Duty free items:**

Personal gifts of which the applicable import duty/tax does not exceed \$80.

200 cigarettes for every person above 18 years of age.

Camera or Video camera.

Personal effects, such as perfume and clothing.

Personal computer (laptop and tablet).

Equipment for professional use.

## prohibited items:

Alcoholic Beverages.

Any kinds of plants or animals.

Narcotics, toxic substances, and their relevant applicants.

Weapons, ammunition, explosive and radioactive substances.

Antique and art objects including books and magazines.

All kinds of precious metals/stones.

# 9. EXHIBITION ITEMS

There are **no customs duties applicable for items imported for the exhibition** at the ICAO Trip Seminar. # 11. CURRENCY, CREDIT CARDS AND BANKING SERVICES (\*CREDIT CARDS ARE NOT ACCEPTED\*)

The unit of currency in I.R. of Iran is Iranian RIALS. The current rate of exchange for US1\$ is approximately 35,000 RLS. There are no restrictions on the import of foreign currency.

Commercial banks and exchange bureaus are open from 0800 to 1500 (*Closed on Fridays*). All major foreign currencies are accepted for exchange.

## **SHOPPING**

Be prepared to bargain in small shops and with sidewalk vendors. However, in large stores, prices are fixed.

## **TOURISM**

Kish Island, often called the Pearl of the Persian Gulf has an area of 90 square km (36 sq. miles). It is known for being a beautiful resort in the Middle East and the Persian Gulf. Swimming and boating is available on the Persian Gulf.

## 13. TAP WATER
