Considering the progress made in the implementation of the ATS Message Handling System (AMHS) in the NAM/CAR Regions, to follow-up the Regional NAM/CAR AMHS Implementation Plan, and considering the AMHS system interconnection of Dominican Republic, the Federal Aviation Administration (FAA) of United States, the Instituto Dominicana de Aviación Civil (IDAC) and ICAO will convene the **III Workshop/Meeting on the follow-up to the Implementation of the ATS Message Handling System (AMHS) in the NAM/CAR Regions** to be held in Santo Domingo, Dominican Republic, from 24 to 26 September 2013, to which I have the honor to invite your Administration/Organization to participate.
