I have the honour to inform you that the Latin American and Caribbean Association of Airfield Pavements (ALACPA), jointly with ICAO, United States FAA and the Airports Directorate of Chile is organizing the XI ALACPA Seminar of Aerodrome Pavements/IX FAA Airport Pavements Workshop/IV Short Course for Airfield Pavement to be held at the Galerías Hotel in Santiago, Chile, from 1 to 5 September 2014.

The main objective of the workshop is to exchange technical experience and knowledge for improving airport pavements consequently contributing to airport safety in the Region. The opening ceremony will be held on Monday, 1 September 2014, at 9:30 hours, in the Gran Mapuche Room of the Galerías Hotel.

During the month of September, the temperature in Santiago, Chile, varies from 4°C (40°F) to 18°C (64°F); average relative humidity is 70 %. The capital of Chile is Santiago, which has Mediterranean weather with well-defined seasons. Spring falls between September and November; summer falls between December and February; autumn falls between March and May; and winter is from June to August.

## 6. Money Exchange

The national currency is the Chilean Peso. Currently, the exchange rate is equivalent to approximately \$550 per \$1 USD. Currency exchange is available at AFEX Money Exchange, located in Moneda Street  $N^{\circ}$  1148 or in "Cambios Guiñazú", Matías Cousiño Street  $N^{\circ}$  170. An additional option for exchange is available with bank/debit cards at Redbanc ATMs machines (maximum \$200.000 per day / US\$365 approx.).
