#### 1. Introduction

- 1.1 Air Transport Facilitation comprises a series of problems and activities that States address according to the application of the Standards and Recommended Practices (SARPs) of Annex 9 to the Chicago Convention on Facilitation.
- 1.2 In this regard, Article 22 of the Convention, considered the obligation of each State to "adopt, through the issuance of special regulations or otherwise, all possible measures to facilitate and expedite navigation by aircraft between the territories of the Contracting States and to prevent unnecessary delays to aircraft, crews, passengers and cargo, especially in the implementation of the laws on immigration, quarantine, customs and clearance".

- 1.3 Moreover, the ICAO Doc 9957 Facilitation Manual, provides support to States to achieve goals such as "increase the level of knowledge of the issues and concepts of facilitation; improve outcomes of facilitation programs in the States; and increase compliance with Annex 9".
- 1.4 The working paper submitted by Chile 17/05/13 NE/23 during the Third Meeting AVSEC/FAL/RG/3 proposes to create a database with "Facilitation Best Practices" by the Member States

# 2. Bolivian Experience Rules on Air Transport Facilitation

- 2.1 The Directorate General of Civil Aviation (DGAC) of Bolivia established, adopted and implemented a National Facilitation Program Air Transport during the 2005 period. Additionally, in 2009 adopted two Bolivian Aeronautical Regulations (RAB) on Facilitation, RAB 997 "Regulations on Airport Facilitation Manager" and RAB 999 "Regulations for Air Operator Facilitation", both stipulate the obligation to develop Facilitation and Airport Manager Air Operators programs.
- 2.2 Whereas regulations had already been socialized and applied to Aeronautics Bolivian community is the need to begin with the development of specific programs for administrators and operators Facilitation.
- 2.3 In this regard, the FAA developed a "Model Program Facilitation", whose index is attached as an **Appendix** to this paper, which sets out the methodology to be employed. During its development, the field technicians worked in coordination with the Directors of Airports to obtain the stated objective.
- 2.4 Currently has Facilitation Programs approved for Administrators Airports, documents that frame all the procedures that are used in the entry, transit and departure of passengers, crew, baggage, cargo and mail, also the detail of all the infrastructure, services and information provided by the Airport Manager, and coordination with these border control authorities. An important part of this program is Attachment A that develops all airport signage should have airports according to their infrastructure.

### 3. **Proposal of Model Program Facilitation**

3.1 Having obtained favourable results for inspections on Facilitation through the National Facilitation Program, the Administrator of Bolivia puts in consideration of the States a "Model Program" to be considered and implemented in their States, if applicable.

#### 4. Suggested Action

4.1 Considering that this is a "Best Practice FAL", the meeting is invited to discuss the present working paper to be incorporated in the database established for this purpose.
