#### Sir/Madam:

Further to the ICAO mandate to develop Safety and Air Navigation targets for the Regional Performance Dashboard, I have the honour to invite your Administration/Organization to participate in the **CAR Region Safety and Air Navigation Directors Meeting (CAR/DCA/OPSAN)** to be convened at the ICAO NACC Regional Office, Mexico City, Mexico, from 18 to 19 February 2014. The working languages of the meeting will be English and Spanish, and simultaneous interpretation will be provided if sufficient participants of both languages provide timely registration.

This meeting is specifically convened for the Flight Safety and Air Navigation Directors of States and Territories of the CAR Region. Representatives of invited international organizations are also expected to attend.

The objective of this meeting is to review and agree on the preliminary safety and air navigation targets and respective indicators proposed by ICAO within the framework of the Global Aviation Safety Plan (GASP) and the Global Air Navigation Plan (GANP). The said Air Navigation Targets are the ones proposed by the first meeting of the NAM/CAR Air Navigation Implementation Working Group (ANI/WG/01), with some adjustments, and included in the NAM/CAR Regional Performance-Based Air Navigation Implementation Plan (RPBANIP), Version 3.0.

The agreed targets determined at this meeting will be presented for its respective approval to the Fifth Meeting of North American, Central American and Caribbean Directors of Civil Aviation (NACC/DCA/5) to be held in Port of Spain, Trinidad and Tobago, from 28 to 30 April 2014.

One of the outcomes of the NACC/DCA/5 Meeting will be the "Declaration of Port-of-Spain," which will contain the above-mentioned safety and relevant air navigation targets. The agreed NAM/CAR Regional targets of the "Declaration of Port of Spain" will be published on the ICAO Regional Performance Dashboard website for monitoring target achievement.

The Provisional Agenda of the meeting is at **Attachment A**. States wishing to submit proposals for the addition of items should do so by **10 January 2014**.

You are kindly requested to complete in Word and send by e-mail the Registration Form at **Attachment B** for each participant by **3 February 2014**.

Working papers should be brief, action-oriented and focused, with a four-page limit excluding any appendices.

Only working papers <u>received</u> by this office by <u>3 January 2014</u>, submitted by States/Territories, will be translated to ensure timely processing. Working papers received in this office <u>after</u> that date will have to be sent in both languages. Information Papers will only be issued in the language of submission. Papers received from international organizations will not be translated and will be issued only in the language submitted. The deadline to receive papers is <u>31 January 2014</u>. The deadlines for submission of documentation for translation will be strictly enforced. You are encouraged to submit documentation in both meeting languages (i.e., English and Spanish).
