1. Introduction

1.1 In accordance to ICAO's Tender (Sealed Tender ST-22501390) and the invitation for contract negotiation by ICAO in December 2013, COMSOFT started the contract negotiation procedure with each MEVA III Member State.

1.2 In parallel, MEVA III TF and COMSOFT negotiated the Service Level Agreement (SLA) which will be apply as a general document of the MEVA III Network and be part of each individual contract.

2. Negotiation Procedure

2.1 Based on the situation that COMSOFT has to negotiate the MEVA III contract with each Member State on an individual basis, COMSOFT decided to perform the negotiation procedure as follows.

- Preparation and submission of a dedicated Framework Agreement
- Negotiation and definition of Change Requests by the Member States
- Definition of Service / Delivery Package of each Member State
- Preparation of final contract documentation (Framework Agreement, SLA, Attachments)

3. Service Level Agreement

3.1 COMSOFT submitted a draft of a dedicated Service Level Agreement (SLA) to MEVA III TF for review and comments / change requests.

3.2 The change request process of the Service Level Agreement was finalized in May 2014 and the final version of the Service Level Agreement (English version) was submitted and approved by MEVA III TF.

3.3 COMSOFT translates the finalized Service Level Agreement into Spanish and will submit this version to MEVA III TF as well in week 22 (End of May 2014).

4. Status of Contract Negotiation Procedure

4.1 The table below was developed by MEVA III TF and COMSOFT to get an overview of the status of the contract negotiation procedure with each Member State.

4.2 The latest version of such status is dated for 23 May 2014.
