1. Introduction

- 1.1 Of the main objectives to be reached with the improvements in the GREPECAS mechanism based in Programmes and Projects as presented in **Appendix A**, following the ICAO Council requirements, and the ICAO Air Navigation Commission (ANC), the following aspects were required:
 - Increase effectiveness more tangible/measurable and performance-based results
 - Enhance efficiency reduce time to achieve approvals, actions and results; improved internal coordination between different bodies, participants and responsibilities; project management methodology

- Reduce costs less, shorter and smaller site meetings; more remote access meetings, teleconferences and correspondence
- Align GREPECAS with contemporary ICAO strategic objectives, programmes, projects, activities and tasks methodology

2. Discussion


- 2.1 The GREPECAS/16 Meeting provided important Conclusions for State's implementation, which were later followed-up during the GREPECAS annual meetings in 2012 and 2013 (Project and Programme Review Committee PPRC/1 and PPRC/2). **Appendix B** shows the outstanding GREPECAS Conclusions.
- 2.2 Regarding the projects proposed in GREPECAS/16, which are composed of the State experts, their sole purpose is to assist in the implementation by States with useful deliverables as needed. The projects have the following components:
 - Objectives, Description
 - Activities, Responsibilities
 - Resources experts and budget
 - Results- Products, Deliverables
 - Schedule, Programming, Milestones, Periods
 - Metric / Indicators and
 - Risks Assessment
