In accordance with the Regional Performance Objectives (RPOs) of the NAM/CAR Regional Performance-Based Air Navigation Implementation Plan (RPBANIP); specifically, RPO 4 - *Improve Situational Awareness*; the implementation of ICAO Aviation System Block Upgrades (ASBUs) B0 modules: B075/SURF - *Safety and Efficiency of Surface Operations*; B084/ASURF - *Initial Capability for Ground Surveillance*; the promotion of radar data sharing; Automatic Dependent Surveillance-Broadcast (ADS-B) activities in the NAM/CAR Regions; and Conclusion 3/6 - *ADS-B trials and analysis in the CAR Region* from the Third North American, Central American and Caribbean Working Group Meeting (NACC/WG/3), I wish to invite your Administration/Organization to participate in the Automatic dependent surveillance – broadcast (ADS-B) Implementation Meeting (ADS-B/IMP), that will be conducted by the NAM/CAR Air Navigation Implementation Working Group (ANI/WG) ADS-B Implementation Task Force at the ICAO NACC Regional Office, Mexico City, Mexico, from 27 to 29 April 2015.

**Only** working papers **received** by this office by **9 March 2015**, submitted by States/Territories, will be translated to ensure timely processing. Working papers received in this office **after** that date will have to be submitted in both languages. Information papers will only be issued in the language submitted. Papers received from international organizations will not be translated and will be issued only in the language submitted. The deadline to receive papers is **17 April 2015**. The deadlines for submission of documentation for translation will be strictly enforced. You are encouraged to submit documentation in both meeting languages (i.e., English and Spanish).

Furthermore, in accordance with the 2013-2016 Activities Plan of the Regional Technical Cooperation Project for the Caribbean Region – *Implementation of Performance-Based Air Navigation Systems for the CAR Region (RLA/09/801)*, and, specifically, with the Sub-Project 4. **Enhance ATS situational awareness**, I am pleased to inform you that this event is offering one fellowship to each Project Member<sup>1</sup>.
